Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Inhalation of solvent fumes, Direct contact with solvents/adhesives	3H	<ul style="list-style-type: none"> - Conduct a risk assessment prior to commencing work to identify potential exposure levels and necessary precautions. - Ensure adequate ventilation in the work area using mechanical exhaust systems or natural airflow to disperse fumes. - Use solvent adhesives that have low volatile organic compound (VOC) content whenever possible to reduce harmful emissions. - Equip workers with appropriate personal protective equipment (PPE) including respirators or masks specifically designed for solvent fume protection. - Position fans and air movers to direct solvent fumes away from the breathing zone of workers. - Implement a strict no-smoking policy in and around the work area to prevent ignition of flammable solvents. - Provide training sessions to workers on safe handling, use, and storage of solvents and adhesives. - Use sealed containers for storing solvents and adhesives when not in use to minimise evaporation into the work space. - Establish designated areas for mixing and applying solvent-based adhesives, clearly marked and away from other work activities. - Regularly monitor air quality in the work environment using gas detection equipment to ensure fume levels remain within acceptable limits. - Schedule tasks involving solvents during times when fewer people are present to limit overall exposure. 	2M
2. Equipment Check	Accidental spills, Exposure to faulty equipment	3H	<ul style="list-style-type: none"> - Conduct a thorough inspection of all equipment prior to use to ensure it is in good working condition. - Use spill containment kits strategically placed around the work area to manage any accidental spills promptly. - Ensure all employees are trained on proper spill response procedures and equipment handling techniques. - Perform regular maintenance checks and servicing of ventilation systems to minimise the risk of equipment failure. - Label and store solvents and adhesives properly to prevent accidental spillage or exposure. - Implement a lockout/tagout system for faulty equipment until repairs or replacements can be conducted. - Provide employees with appropriate personal protective equipment (PPE) such as gloves and masks when handling solvents or adhesives. - Establish clear communication protocols for reporting spills and equipment malfunctions immediately. - Install protective barriers or screens around equipment to contain potential spills within a defined area. 	2M

Ventilation Check	Inadequate ventilation, recirculation of hazardous fumes		<ul style="list-style-type: none"> - Ensure all work areas are fitted with mechanical ventilation systems capable of managing solvent and adhesive fumes efficiently. - Position local exhaust ventilation (LEV) systems close to the source of fumes to minimise worker exposure. - Regularly inspect and maintain ventilation equipment to ensure it is operating effectively without blockages or malfunctions. - Establish a schedule for checking airflow rates to verify that ventilation systems are functioning within required specifications. - Implement natural ventilation by opening windows and doors where possible and safe to do so, supplementing mechanical systems. - Use personal air monitoring devices to measure airborne contaminant levels and ensure they are below workplace exposure standards. - Avoid directing exhaust outlets near intake vents or open windows to prevent re-circulation of harmful fumes back into the workspace. - Install air filtration systems equipped with activated carbon filters to capture and neutralise solvent fumes before release into the atmosphere. - Train workers on recognising inadequate ventilation conditions and the importance of reporting issues immediately. - Maintain an emergency response procedure for situations where ventilation becomes compromised or fume levels exceed safe limits. - Configure workstations to increase airflow paths and reduce concentration zones of hazardous vapours. - Utilize sealed containers for storage of volatile solvents and adhesives to limit evaporation and off-gassing in shared work spaces. - Schedule work involving high-fume materials during low occupancy periods to reduce overall exposure risk. - Conduct regular indoor air quality assessments to identify potential ventilation improvement opportunities and address them promptly. 	3H



SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
