Ensure all workers have appropriate personal protective equipment including hard hats, steel-toed boots, and gloves. Use mechanical aids such as forklifts or trolleys to lift and move heavy materials whenever possible. Secure loads with straps or restraints before moving them to prevent shifting or falling. Maintain a safe distance from suspended loads during unloading. Establish a designated unloading area that is flat, stable, and free of obstructions. Implement exclusion zones around the unloading area to restrict access to authorised personnel only. Provide adequate supervision and guidance from trained personnel during unloading operations. Train workers in correct manual handling techniques to minimise the risk of injury from lifting. Inspect tools and equipment prior to use to ensure they are in good condition and functioning properly. SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.
