Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

This includes keeping them away from areas where accidental spills may increase the risk of slips and falls. - Develop and implement a spill response plan in case of accidental release of hazardous materials. This plan should include spill containment procedures, spill cleanup measures, and appropriate waste disposal methods. - Install appropriate signage and barriers to warn personnel about potential slip, trip, and fall hazards or the presence of hazardous materials in the work area. For example, use "Caution: Wet Floor" signs if waterproofing materials have been applied recently. - Regularly inspect and maintain walking surfaces around the work area to ensure they remain in good condition, free from defects, and provide adequate grip to minimise the possibility of slips and trips. - Provide adequate training for workers on the correct handling, storage, and disposal of hazardous materials involved in the waterproofing process, as well as guidance on how to avoid slips, trips, and falls during their daily tasks. - Monitor ongoing activities to ensure control measures are being followed, and promptly address any deviations from established safety procedures to prevent accidents related to slips, trips, falls, or exposure to hazardous materials. - Review Safety Data Sheets (SDS) for all hazardous chemicals used in the waterproofing process, and communicate the necessary safety precautions, proper handling techniques, and exposure risks to all workers. - Encourage workers to report any hazardous conditions or incidents related to slips, trips, falls, or chemical exposure immediately to their supervisor, so that corrective action can be taken and evaluated for effectiveness. 	1L

Opt for mild cleaning solutions as an alternative. - Emergency eyewash stations: Install emergency eyewash stations at strategic locations around the worksite to enable quick and easy access to rinsing facilities in case of accidental contact between chemicals and eyes. - First aid supplies: Keep a well-stocked first aid kit on hand and readily accessible to all staff in case of an injury. SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
