Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Operator injuries, Trips and falls, Exposure to chemicals	3H	<ul style="list-style-type: none"> - Conduct a comprehensive risk assessment before beginning any work activities in the winery to identify potential hazards and implement appropriate controls. - Provide all workers with thorough training on safe work practices, including the correct use of tools and equipment specific to winery operations. - Ensure that all workers are wearing the appropriate personal protective equipment (PPE), such as gloves, safety glasses, non-slip footwear, and aprons where necessary. - Maintain clear pathways and organise work areas to reduce trip hazards; ensure that hoses and cables are secured and not left in walkways. - Implement clear signage and barriers in areas where slips and trips are likely to occur, especially around wet or uneven floors. - Store all chemicals used in the winery in marked, designated areas; ensure that containers are sealed and have current Safety Data Sheets (SDS) available for reference. - Establish and enforce proper manual handling techniques to prevent operator injuries from lifting heavy or awkward loads such as barrels or crates. - Verify that all equipment is regularly inspected and maintained in good working order, with guards and safety features intact. - Use mechanical aids, like forklifts or trolleys, whenever possible to move heavy items safely. - Limit exposure to noise by requiring hearing protection in high-decibel areas and monitoring sound levels within the facility. - Ensure emergency procedures, including spill response and ventilation, are established for chemical exposure incidents and all staff are trained in these procedures. - Provide regular health surveillance for workers who may be exposed to chemicals to detect any adverse health effects early. - Encourage a culture of reporting hazards and near-misses among employees to continuously improve workplace safety. - Supervise work activities to ensure compliance with safety procedures and address any unsafe actions immediately. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
