Safety meetings or toolbox talks will be sched and in account with gislative requirements to first identify any site hazards, and then to further take steps to either eliminate or continuous each hazard.			
If an incident or a near miss occurs, all work must sto, adately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Use condrails to be sets on the sides of the trailer to prevent falls from height. Train all to rikers to safe work practices and emergency procedures specific to working at heights on trailers. Have an pottle or supervisor present to monitor work and immediately address any hazards. Income it a system of check-ins to ensure lighting and other safety measures are maintained through the task. Insure there are sufficient handholds or other means for workers to maintain three points of contact with working on the trailer. 	1L
2. Perform equipment check	Electric shock, Faulty machinery parts	ЗН	 Ensure all equipment is checked and tagged by a qualified electrician. Inspect cords for any signs of wear or damage. Use only equipment that meets Australian standards and is in good working condition. Perform regular maintenance checks on all machinery and document these inspections. Replace faulty machinery parts immediately and do not use equipment until repairs are completed. Wear appropriate personal protective equipment (PPE), including insulated gloves if dealing with electrical components. Ensure all safety switches and emergency stops are functioning correctly. Follow lockout/tagout procedures to ensure machinery cannot be operated during inspections. Verify that all electrical connections are secure and there are no loose wires. Make sure that the ground around the trailer is dry to prevent electric shock from damp conditions. Use non-conductive tools when performing equipment checks around electrical components. Establish a safe work zone with barriers to keep non-essential personnel away from the inspection area. 	2M

SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

- Spot Checks.
- 2. Consultation with workers, contractors and sub-contractors.
- Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
