ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Ladder Dismantling	Muscle strains due to improper lifting techniques, Falling from height	2M, 3H	<ul style="list-style-type: none"> - Ensure all workers have received adequate training in proper lifting techniques. - Conduct a pre-task safety meeting to discuss the procedure for ladder dismantling. - Use a spotter to assist and guide during the ladder dismantling process. - Check that the ground surface around the ladder is stable and clear of debris. - Wear appropriate personal protective equipment, including gloves with grip support. - Utilise proper manual handling aids like trolleys or hoists where possible to minimise lifting. - Assess the weight of ladder components and dismantle in smaller sections if feasible. - Maintain three points of contact when climbing up or down ladders. - Clearly communicate each step with team members involved in the task. - Avoid overreaching or twisting while dismantling and handling ladder parts. - Position yourself squarely in front of the ladder when lifting components to reduce muscle strain. - Follow manufacturer guidelines for dismantling specific ladder types and models. - Ensure proper housekeeping by storing dismantled ladder parts in designated areas to prevent tripping hazards. 	1L, 2M

			<ul style="list-style-type: none"> - Designate specific storage zones within the attic space that are clearly marked and communicated to all workers. - Store heavy items on lower shelves or racks to reduce the risk of falling objects. - Securely fasten shelves and storage racks to prevent them from tipping over. - Use bins or containers with lids for smaller items to prevent spills and tripping hazards. - Keep pathways and work areas clear of stored equipment to maintain access and reduce trip hazards. - Implement a tagging system for identifying and organising stored materials. - Regularly inspect stored items to ensure they are secure and not at risk of falling. - Use appropriate lifting techniques and equipment when moving heavy items into and out of storage spaces. - Instruct workers on proper stacking methods to ensure stability and safety. - Provide training on hazard awareness related to stored equipment in confined spaces. - Secure tools and materials that are not in use, using hooks or restraining straps where applicable. - Ensure adequate lighting in storage areas to improve visibility and reduce accident risks. - Conduct regular audits of storage practices to identify potential hazards and make necessary improvements.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
