Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Heat exhaustion, Dehydration	3H	<ul style="list-style-type: none"> <li>- Conduct a pre-work briefing to educate all workers about the risks of heat exhaustion and dehydration.</li> <li>- Schedule work during cooler parts of the day such as early morning or late afternoon, to minimise exposure to high temperatures.</li> <li>- Ensure adequate shaded rest areas are available near the working site for regular breaks.</li> <li>- Mandate frequent breaks in cool shaded areas to give workers time to recover from any symptoms of overheating.</li> <li>- Provide ample supplies of cold drinking water and encourage workers to hydrate at regular intervals, even if they do not feel thirsty.</li> <li>- Supply electrolyte drinks or supplements to help replenish lost nutrients and minerals from sweating.</li> <li>- Implement a buddy system where workers look out for signs of heat stress in their colleagues.</li> <li>- Require appropriate clothing such as light-colored, loose-fitting, and breathable fabrics that aid in keeping the body cool.</li> <li>- Ensure that personal protective equipment (PPE) is suitable for hot conditions and does not unintentionally increase the risk of heat exhaustion.</li> <li>- Monitor weather conditions continuously and adjust work schedules accordingly if extreme heat warnings are issued.</li> <li>- Install cooling stations with fans or misting systems to provide additional relief from heat exposure.</li> <li>- Train employees in recognising symptoms of heat-related illness and the immediate actions to take if they occur.</li> <li>- Develop an emergency response plan specifically addressing severe heat-related incidents and ensure all workers are familiar with it.</li> </ul>	2M

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
