Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Tripping, Falling Objects, Noise Exposure	3H	<ul style="list-style-type: none"> - Conduct a thorough site assessment to identify potential tripping hazards and clear any obstacles from the work area before commencing operations. - Use clearly visible signage to alert workers and visitors of areas where cranes and heavy machinery are operating, minimising the risk of entry into hazardous zones. - Install physical barriers or safety fencing to delineate safe walkways and prevent unauthorised access to operational zones. - Ensure all personnel in the vicinity wear appropriate personal protective equipment (PPE), such as hard hats and high visibility clothing, at all times. - Implement a comprehensive induction program for all workers, detailing specific risks associated with working near cranes and other machinery and the importance of adhering to safety protocols. - Schedule regular maintenance and inspections of machinery to prevent malfunctioning, which could result in falling objects or other hazards. - Utilise spotters or dedicated safety personnel to guide machinery movement and monitor surrounding activities, ensuring no obstructions or individuals are in the immediate vicinity. - Enforce a strict exclusion zone around crane operations, permitting only essential personnel in close proximity, while others maintain a safe distance. - Provide hearing protection to workers who are exposed to excessive noise levels and conduct regular monitoring to ensure compliance with workplace noise regulations. - Develop an effective communication system, such as two-way radios or hand signals, to facilitate clear and concise instructions among workers and operators to mitigate miscommunication risks. 	2M

Operational Checks	Caught In Between or Moving Machinery Parts		<ul style="list-style-type: none"> - Ensure thorough training of all personnel on safe operational procedures and awareness around machinery. - Implement a strict lockout/tagout procedure to secure machines whenever maintenance or inspections are carried out. - Conduct regular and comprehensive safety audits to identify potential hazards and rectify them immediately. - Maintain clear signage and barriers around the working area to prevent unauthorised access and inform workers about operational zones. - Use spotters or signal personnel to guide crane operations and communicate effectively with machine operators. - Equip all machinery with emergency stop buttons that are easily accessible in case of an incident. - Regularly inspect and maintain machinery to ensure that all safety features are functional and up-to-date. - Establish and enforce a minimum exclusion zone around machinery for non-essential personnel. - Ensure all machinery parts are properly guarded to prevent accidental contact during operations. - Provide appropriate personal protective equipment (PPE) such as helmets, high-visibility clothing, and safety boots to all workers in proximity to machinery. - Implement a clear communication system using radios or hand signals to coordinate movements and emergency instructions. 	3H

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
