Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Accessing the slope	Trip hazards, Falling from height	3H	<ul style="list-style-type: none"> - Conduct a pre-job site inspection to identify and assess trip hazards such as loose rocks, roots, or debris. - Implement clear access paths marked with high visibility tape or signs to guide workers safely on uneven ground. - Ensure all personnel are equipped with appropriate personal protective equipment, including sturdy non-slip footwear. - Use harnesses and fall arrest systems when working near steep edges or on elevated slopes to protect against falls from height. - Limit the number of workers accessing the slope at any one time to maintain safe distances and prevent overcrowding. - Provide proper training on the recognition of potential trip hazards and techniques for maintaining balance on uneven surfaces. - Utilize spotters to assist workers navigating challenging sections of the slope, providing guidance and additional safety assistance. - Assess weather conditions regularly and halt work activities on slopes if rain, ice, or other adverse conditions increase the risk of slipping. - Install temporary safety barriers or guardrails along the most hazardous areas of the slope to ensure workers do not accidentally approach dangerous edges. - Employ mechanical aids or equipment designed for slope navigation to transport materials safely, reducing manual handling risks. - Maintain clear communication among team members regarding identified hazards and implement a buddy system to watch for potential safety incidents. - Regularly monitor and maintain access routes to prevent the accumulation of new hazards such as mud build-up or erosion. - Establish an emergency response plan specific to the nature of the slope, ensuring quick reaction capabilities in case of a slip, trip, or fall incident. - Rotate tasks frequently to minimise fatigue, which can increase the likelihood of missteps or loss of footing on uneven terrain. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
