The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Clearly mark and restrict access to areas identify as unstable to prevent unauthorised entry. Ensure all workers are trained in recognising any evoiding working on unstable or potentially dangerous surfaces. Provide appropriate and all projective equipment (w. E) such as non-slip footwear with sufficient grip. Use guardre or barriers cound to table entries to prevent falls from heights. Install warning lights to out workers to others to the presence of unstable surfaces and related risks. Employ ampora confilication methods, such as plywood sheets or scaffolding, to provide a safer working proform. Implement to hidy systems where workers can check each other's safety equipment and movements onsite. Our sluce egular pafety briefings and toolbox talks to reinforce awareness of unstable surface hazards. Ensure to per lighting is installed to enhance visibility, especially in dimly lit areas. Is the stability of surfaces by applying pressure incrementally and observe any deformation or movements. Develop an emergency response plan specific to incidents arising from working on unstable surfaces. Limit the number of workers on an unstable surface at any given time to reduce the risk associated with overloading. 	1L
2. Setting Up Area	Inadequate lighting, Loss of balance on rough terrain	2M	 Ensure adequate lighting is available and working properly, especially during low-light conditions or night shifts. Use portable lighting solutions such as LED floodlights to illuminate the work area effectively. Conduct a site assessment prior to beginning work to identify potential hazards related to the terrain and lighting. Clearly mark uneven or hazardous areas with high-visibility cones or tape to alert workers. Provide workers with headlamps or flashlights if the work requires frequent movement in poorly lit areas. Implement a buddy system so that workers can assist each other in maintaining balance and navigating difficult terrain. Use non-slip footwear designed for rough or uneven surfaces to reduce the risk of falling. Level and stabilise ground surfaces where possible to create a safer working environment. Erect temporary barriers around particularly unstable areas to prevent accidental entry. 	1L



SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

- Spot Checks.
- 2. Consultation with workers, contractors and sub-contractors.
- 3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
