Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Safety hazards, Health hazards	3H	<ul style="list-style-type: none"> - Conduct a thorough risk assessment of the site to identify and evaluate potential safety and health hazards associated with working with demolished plasterboard. - Provide worker training on the specific risks identified and the safe methods for handling and disposing of demolished plasterboard, ensuring all workers are informed and competent. - Ensure all personal protective equipment (PPE) such as dust masks, gloves, and eye protection are readily available and worn by all workers handling or processing plasterboard waste. - Implement dust control measures such as using dust extractors, wetting down materials, and employing containment methods to minimise airborne particles. - Establish and maintain clear communication lines among site staff regarding ongoing activities, known hazards, and emergency procedures. - Designate specific areas for the collection and segregation of demolished plasterboard waste to prevent contamination and ensure organized disposal processes. - Monitor air quality regularly in work zones to ensure levels of dust and particulates do not exceed recommended exposure limits. - Limit access to designated demolition zones to authorised personnel only, using physical barriers and signage to enforce boundary controls and minimize unauthorised entry. - Inspect tools and equipment regularly to ensure they are in good working order and appropriate for handling plasterboard materials, removing defective items from service immediately. - Develop and communicate an emergency response plan outlining steps to take in case of injury, hazardous material exposure, or other incidents while working with demolished plasterboard. - Schedule routine health surveillance programs for workers who regularly handle demolished plasterboard to detect early signs of dust-related illnesses. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
