Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Calibration	Electrical shock, Exposure to harmful light source	3H	<ul style="list-style-type: none"> - Conduct training sessions for workers on the risks associated with large format digital print machinery and proper calibration procedures. - Ensure that only authorised and trained personnel perform calibration work on the machinery to minimise risk of improper handling. - Switch off and isolate the machine from the main power supply before beginning any calibration activities to prevent electrical shock. - Inspect all electrical cables and connections for signs of wear or damage before operation, and replace any faulty components immediately. - Use lockout/tagout (LOTO) systems during calibration tasks to ensure machinery remains de-energised while work is being carried out. - Avoid working alone; ensure there is always someone present who can provide assistance or summon help in case of an emergency. - Provide personal protective equipment (PPE), such as insulated gloves and appropriate eyewear, to protect against electrical hazards and harmful light exposure. - Install appropriate safety signage and barricades around the calibration area to alert others to potential dangers. - Employ automatic shut-off features or emergency stop mechanisms where possible to quickly disconnect power in case of an incident. - Regularly test the machinery's built-in safety features to ensure they function correctly and provide suitable protection. - Limit exposure times to the light source by planning the calibration schedule efficiently and taking breaks if necessary. - Utilise shielding or filters when dealing with potentially harmful light sources to reduce workers' direct exposure. - Keep an updated risk assessment and consistently review and improve procedures based on new information or incidents. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
