Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

			- Promote regular team communication and planning when moving or treating animals. This can minimise unforeseen situations causing stress to both animals and staff. - Utilise mechanical lifting aids when dealing with heavy animals or supplies to protect staff from potential back injuries. - Regularly review and update animal handling procedures to ensure they are up-to-date with the latest industry standards and best practice advice. - Encourage consistent reporting of any safety incidents or near misses, allowing analysis and implementation of preventative actions where necessary. - Ensure all cages, pens and all other infrastructure used to house and transport animals are solidly built, regularly inspected and maintained to avoid accidental escapes or harm to workers. - Support a working culture that focuses on safety first. Empower employees to voice their concerns if they feel an animal is too stressed or a situation poses undue risk.

Quarantine Area Setup	Slips, trips and falls, Injury from setting up enclosures	2M	Sure, there are 11 control measures for setting up a quarantine area in the animal care field: - Ensure adequate lighting is available during the setup process to minimise the risk of trips and falls. - All personnel involved should wear proper personal protective equipment, including non-slip footwear, to reduce the possibility of slips and falls. - Any spillages or wet areas that could contribute to slip hazards should be promptly cleaned. - Make sure all equipment used in the area setup is regularly checked for safety and functionality. - Keep workplace clean and free of clutter to prevent accidents caused by tripping over misplaced objects. - Provide clear signage to indicate zones where setup is ongoing or where there could be potential hazards. - Train staff on how to correctly handle and move materials during the setup process to prevent injuries. - Where possible, use mechanical aids instead of manual handling to safely move heavy equipment or supplies. - Regularly inspect the quarantine area during setup to identify any newly formed hazards. - Establish a failsafe communication system so problems can be quickly reported and addressed. - Implement an ongoing safety education programme to keep all staff aware of the importance of health and safety while setting up the quarantine area.	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
