If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

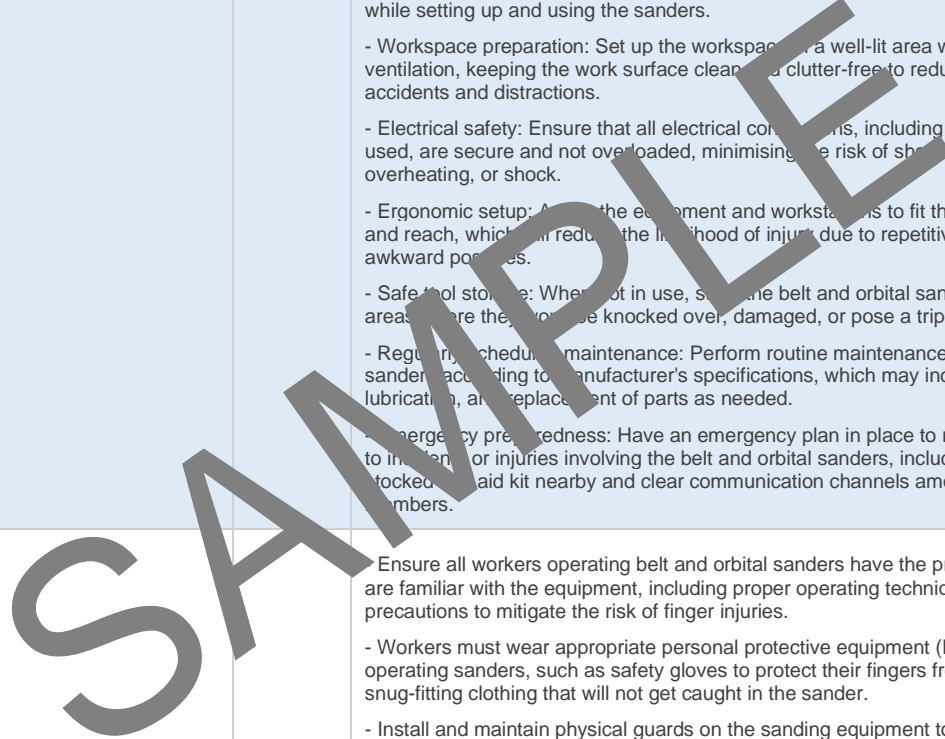

Preparation	Tripping on cords, Exposure to dust	2M	<ul style="list-style-type: none"> <li>- Ensure that the work area is free of any debris, clutter, or other trip hazards before starting work, and maintain a clean environment throughout the project.</li> <li>- Inspect cords and cables, including extension cords and power boards, to ensure they are in good condition and without any visible damage such as fraying or exposed wires.</li> <li>- Use cable organisers, cable cover or cable ties to securely manage loose cords and prevent them from becoming tangled or creating a trip hazard on walking paths.</li> <li>- Position cords and equipment away from walkways and high traffic areas to reduce the risk of tripping; consider using temporary barriers if necessary.</li> <li>- Ensure that all workers involved in the project receive appropriate training and are made aware of Workplace Health and Safety requirements for using belt and orbital sanders.</li> <li>- Provide workers with appropriate Personal Protective Equipment (PPE), such as safety glasses/goggles, suitable dust masks or respirators, ear protection, and gloves, to minimise exposure to dust particles.</li> <li>- Use tools and equipment that feature built-in effective dust extraction systems, as well as vacuum cleaners equipped with HEPA filters, to control dust at its source.</li> <li>- Use containment systems or barriers, such as curtains, to limit the spread of dust particles to other areas if working indoors.</li> <li>- Ventilate the work area adequately by opening windows and doors, using exhaust fans, or installing air purifiers to help circulate and filter the air effectively.</li> <li>- Increase the frequency of work breaks to minimise prolonged exposure time to dust particles and reduce overall strain from using the belt and orbital sander.</li> <li>- Ensure proper disposal of collected dust in sealed bags or containers, followed by regular cleaning and maintenance of tools and workspaces, to further mitigate the potential risks posed by dust exposure.</li> </ul>	1L

			<ul style="list-style-type: none"> <li>- Proper PPE: Make sure that personal protective equipment (PPE), such as safety glasses, hearing protection, gloves, dust masks or respirators are worn by workers while setting up and using the sanders.</li> <li>- Workspace preparation: Set up the workspace in a well-lit area with adequate ventilation, keeping the work surface clean and clutter-free to reduce the risk of accidents and distractions.</li> <li>- Electrical safety: Ensure that all electrical connections, including extension cords if used, are secure and not overloaded, minimising the risk of short circuits, overheating, or shock.</li> <li>- Ergonomic setup: Adjust the equipment and workstations to fit the worker's height and reach, which can reduce the likelihood of injury due to repetitive movements or awkward postures.</li> <li>- Safe tool storage: When not in use, store the belt and orbital sanders in designated areas where they will not be knocked over, damaged, or pose a tripping hazard.</li> <li>- Regularly scheduled maintenance: Perform routine maintenance on belt and orbital sanders according to manufacturer's specifications, which may include cleaning, lubrication, and replacement of parts as needed.</li> <li>- Emergency preparedness: Have an emergency plan in place to respond effectively to incidents or injuries involving the belt and orbital sanders, including having a well-stocked first aid kit nearby and clear communication channels among team members.</li> </ul>

**SAFE WORK METHOD STATEMENT MONITORING AND REVIEW**

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
