If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

PPE (Personal Protective Equipment) is the least effective method.

Provide refresher training courses as necessary.</li> <li>- Use appropriate personal protective equipment (PPE) such as non-slip footwear, hard hats, and high visibility vests for workers in the Site Setup area, in order to minimise the likelihood of accidents or injuries.</li> <li>- Implement strict housekeeping measures to keep the work area clean and free from debris, ensuring that walkways and access points are clear to reduce the risk of slips, trips, and falls.</li> <li>- Set up sturdy, level beams or scaffoldings with guard rails and toe boards, where necessary, to provide stable work surfaces for tasks involving brickwork at heights. Inspect and maintain these structures regularly to ensure their safety and integrity.</li> <li>- Use appropriate fall protection systems such as harnesses, lanyards, and anchor points for work at heights, in combination with proper training on their use and regular maintenance checks.</li> <li>- Develop and implement a site-specific emergency response plan for incidents related to falls from heights and uneven terrain, including procedures for immediate medical assistance, evacuation, and reporting.</li> <li>- Encourage a buddy system, where workers are paired up to look out for each other's safety and well-being while working at heights or around uneven terrain.</li> <li>- Encourage open communication among team members and promote a safety culture where workers are encouraged to report any hazards or unsafe work practices, without fear of repercussion.</li> <li>- Regularly review and update the Safe Work Method Statement (SWMS) for brickwork operations to ensure all safety control measures are continuously assessed and adapted to changes on-site or updates to industry standards and regulations.</li> </ul>

The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
