If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Ensure all kitchen staff are trained in safe cooking practices and hazard recognition. Maintain a clean and organised work area to prevent spills and clutter that could cause accidents. Use utensils with long handles to avoid getting too close to hot surfaces and steam. Implement regular maintenance for all cooking equipment to ensure it is functioning correctly and safely. Install temperature gauges on cooking appliances to monitor and control heat levels. Clearly mark hot surfaces and areas prone to generating steam with warning signs to alert staff. Follow proper food handling procedures to minimise the risk of bacterial contamination, including regular hand washing and using sanitised equipment. Adhere to safe cooking temperatures for different foods to prevent the growth of harmful bacteria. Avoid overfilling pots and pans to prevent overflow and splashing of hot liquids. Ensure adequate ventilation in cooking areas to disperse steam and reduce the concentration of potentially harmful particles in the air. Store raw and cooked foods separately to prevent cross-contamination. Have a first aid kit readily available and ensure staff know how to treat burns and other injuries. 	2M
