Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Position hazard cones and warning signs around the truck to alert surrounding traffic and workers. Avoid working close to active roadways; position the truck in a safe, controlled area if possible. Wear high-visibility clothing to increase your visibility to others on-site. Inspect the ground for stability and clear away any debris that could affect ground evenness. If uneven ground is unavoidable, use heavy-duty mats or plates to create a more stable surface. Ensure the jack and other lifting equipment are placed securely on firm, even surfaces. Communicate with all team members to ensure everyone is aware of vehicle movements and positioning activities. Maintain clear communication with the driver to confirm the truck's position and stability before starting work. SAFE WORK IN 'THIS 'S' ITEM ON MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remain effect, and must be reviewed (and revised if necessary) if relevant control measures are revised.
