If an incident or a near miss occurs, all work must standardly. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

2. PPE Selection	Incorrect or faulty PPE	2M	 Conduct a pre-use inspection of all PPE to ensure it is free of damage and defects. Provide training on the correct use and fit of PPE specific to oil spill clean-up activities. Select PPE that is specifically rated for chemical resistance suitable for oil spill scenarios. Ensure PPE fits each worker properly, taking into account individual sizes and ergonomic requirements. Regularly replace PPE components such as gloves and masks according to manufacturer guidelines or sooner if they appear worn. Use only PPE that complies with Australian Standards relevant to protection against chemicals and oil spill hazards. Implement a maintenance program to clean and inspect PPE after each use to maintain its integrity and effectiveness. Label all PPE storage areas clearly and ensure they are easily accessible during an emergency. Provide a variety of PPE options to accommodate allergies or skin sensitivities to materials like latex. Maintain records of PPE distributions and inspections to ensure compliance and traceability. Engage in regular audits of PPE stocks to avoid shortages and ensure availability of high-quality gear. Install identification tags on PPE to assign ownership, reducing the risk of mix-ups or misuse. Encourage workers to report any discomfort or faults in their PPE immediately for timely resolution. 	1L



SAFE WORK IN 'THE 'S' NTEMANT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remain effect, and must be reviewed (and revised if necessary) if relevant control measures are revised. The view as should be carried out in consultation with workers (including contractors as unputractors of the SWMS and their health and safety registeratives who represented that work group at the workplace.

When the SWMS has been revised the PCBD mest ensure the advised that a revision has been made and how they can accept the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties early with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
