Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Ensure all equipment is regularly maintained and serviced according to the manufacturer's guidelines. Provide workers with thorough training on the correct use and inspection of climbing equipment and trailers. Implement a reporting system for workers to immediately report faulty or damaged equipment. Maintain a register of safety gear and conduct regular audits to ensure all gear is in proper working condition. Ensure replacement parts and equipment are readily available to minimise downtime and prevent the use of faulty equipment. Display clear signage reminding workers of the necessity to inspect equipment before use. Provide training for worker on hazard recommon and the importance of adhering to marked pathways and safety procols. 

SAFE WORK IN 'THIS 'S' ITEM ON MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remain effect, and must be reviewed (and revised if necessary) if relevant control measures are revised.
