If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

1. persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
2. persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
3. workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

Preparation	Lack of proper training, Incorrect personal protective equipment use	1H	<ul style="list-style-type: none"> - Ensure that all personnel scheduled to participate in the composting process receive comprehensive training on workplace health and safety practices, including the correct techniques for lifting, moving material and using tools and machinery. - Conduct regular training refreshers to maintain high safety standards and update staff on any changes to safety regulations or processes. - Provide clear, accessible written instructions and safe work method statements (SWMS) pertaining to composting activities, emphasising the importance of adhering to these guidelines. - Require workers to use appropriate personal protective equipment (PPE) such as gloves, safety goggles, dust mask or respirators and long-sleeved shirts and trousers to protect against potential hazards like organic dust and equipment injuries. - Regularly inspect all PPE stocks to ensure they are in good condition, fit for purpose, and readily available to staff when needed. - Implement a buddy system for less experienced staff, pairing them with seasoned employees who can guide them through the correct preparation steps and oversee their adherence to health and safety protocols. - Clearly label all zones where composting activities take place with appropriate warning signs and instructions to remind staff of the need for vigilance and the use of PPE. - Establish a stringent hygiene protocol to prevent the spread of bacteria and other contaminants, including stations for handwashing and sanitisation that are easily accessible to all staff involved in the composting process. - Develop an emergency response plan specifically for the composting area, covering potential incidents such as chemical spills, reactions from exposure to compost materials, or machinery accidents. - Ensure that the workspace is well-ventilated to mitigate the inhalation risks associated with airborne particles commonly found in composting environments. - Regularly review and assess work procedures and control measures to identify opportunities for further improvement in safety practices. - Enforce strict rules prohibiting the consumption of food and beverages in the composting area to prevent accidental ingestion of harmful bacteria or chemicals. - Limit access to the composting area to trained personnel only, preventing unauthorised or untrained individuals from encountering the risks associated with the preparation activities. - Document all training, incidents, inspections, and revisions to procedures in order to maintain accountability and provide a paper trail for continual improvement and compliance checks. 	1L

			<ul style="list-style-type: none"> - Ensure the compost mixture is kept at appropriate moisture levels to reduce the risk of fire or spontaneous combustion. - Provide PPE such as gloves, supportive footwear and back supports to help reduce strain on workers during manual operations. - Implement a buddy system for heavy lifting tasks to distribute the load and reduce individual strain. - Maintain clear communication protocols for workers to report any signs of smoke or excessive heat that may indicate early stages of combustion. - Enforce a strict no-smoking policy in and around the composting area to mitigate fire risks. - Keep fire-fighting equipment such as fire extinguishers easily accessible in the composting area. - Conduct regular inspections and maintenance of mechanical aids to ensure they are functioning safely and effectively. - Establish emergency procedures and conduct regular drills to prepare staff to respond promptly if a fire were to occur. - Monitor the temperature of the compost pile with thermometers to help detect any hotspots that could signal potential combustion issues. - Proper signage should be displayed prominently to inform about potential hazards and preventive measures. - Provide training sessions focused on ergonomics to educate workers on how to conduct tasks in a way that minimises bodily stress. <p>Keep in mind that these control measures must be reviewed regularly and updated as necessary to comply with Australia's workplace health and safety standards. Remember that consultation with workers is key to ensure that these measures are both effective and practical.</p>

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
