Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

			<ul style="list-style-type: none"> <li>- Conduct regular safety briefings and toolbox talks, focusing on current Workplace Health &amp; Safety (WHS) topics relevant to the construction site.</li> <li>- Regularly inspect and level uneven ground surfaces using suitable machinery.</li> <li>- Clearly mark any changes in terrain or other hidden hazards within the worksite with warning signs or temporary fencing.</li> <li>- Implement a buddy system for particularly risky tasks, meaning no worker should be alone when performing these duties.</li> <li>- Ensure a competent person on hand to provide medical care or first aid if needed. They should have up-to-date training and access to a well-stocked first aid kit.</li> <li>- Conduct risk assessments. The results should be used to develop detailed Safe Work Method Statements (SWMS).</li> <li>- Insert physical restoring measures where possible in rest areas, meal breaks, meetings and job site planning activities.</li> <li>- Manage manual handling by reducing excessive lifting, pushing, pulling, carrying and holding. Use available mechanical aids where possible to assist manual handling tasks.</li> <li>- Educate all site personnel on protocols to be followed if a hazard or safety concern is identified. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.

Think of this document as an internal audit review checklist before commencing work, and may form part of a Toolbox Talk (safety meeting) and may be used as an opportunity for education and training.
