If an incident or a near miss occurs, all work must stead dately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Ensure clear signage is placed around the cortaine to alert workers and visitors of wet or uneven surfaces. Provide adequate lighting in chareas where preparation work is being carried out to prevent slips and trips. Mandate there cof appropriate coronal productive equipment (PPE) such as non-slip footwear. Implement to pusekeer gregime coronary clean up spills and remove waste materials that may pose alipping sk. Use to anical cost like trolleys or hoists for moving heavy materials, reducing the need for manual handlers. Train torket on propositifting techniques to minimise strain and reduce the risk of manual handling iuries. Decorption pathways for both pedestrian and equipment movement to prevent overlap and potential collision. On the weight of materials being manually handled and ensure loads are stable before transport. Communicate and display safety procedures clearly on-site to ensure all workers are informed about safe work practices. Conduct a job safety analysis to identify potential hazards and establish appropriate control measures before work begins. Ensure all formworkers are trained and competent in the safe use of tools, equipment, and procedures. Use personal protective equipment such as hard hats, high-visibility vests, and steel-capped boots. Maintain clear communication using radios or other devices between crane operators and formwork crew. Keep work areas tidy and free from unnecessary materials to prevent trips and falls. 

SAFE WORK IN 'THIS 'S' ITEM ON MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remain effect, and must be reviewed (and revised if necessary) if relevant control measures are revised. The view as should be carried out in consultation with workers (including contractors as unputractors of the SWMS and their health and safety registeratives who represented that work group at the workplace.

When the SWMS has been revised the PCBD mest ensure the all persons involved with the work are advised that a revision has been made and how they can accept the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties the total with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.
