Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, to conduct and communicate those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

1. persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
2. persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
3. workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

Preparation	Slips, trips, and falls; improper storage of chemicals	2M	<ul style="list-style-type: none"> <li>- Proper housekeeping: Maintain a clean and well-organised work area, free of clutter and obstructions, to prevent slips, trips, and falls.</li> <li>- Appropriate footwear: Ensure that workers wear slip-resistant footwear suitable for the work environment to minimise the risk of slipping.</li> <li>- Training and supervision: Provide adequate training on correct handling, storage, and use of chemicals, as well as floor washing equipment. Supervise staff to ensure they follow the established workplace policies and procedures.</li> <li>- Clear signage: Place warning signs in areas where wet floors or possible hazards are present, to caution workers and visitors about potential slip and trip risks.</li> <li>- Spill management: Implement a robust spill response procedure to promptly address spills, leaks, and other sources of liquid on the floor. This should include the immediate cleaning of solid liquids and proper containment and disposal methods.</li> <li>- Adequate lighting: Ensure that the work area is well-lit so that employees can clearly identify any potential hazards, such as spills or obstacles, and navigate safely.</li> <li>- Chemical storage: Store cleaning chemicals in a designated area with proper ventilation, away from sources of ignition or incompatible materials, according to manufacturer's guidelines and relevant regulations.</li> <li>- Correct use of equipment: Train employees in the safe operation and maintenance of floor washer (Rotowash) equipment, including correct techniques for handling chemicals and solutions.</li> <li>- Inspect the workspace: Regularly inspect the work area for potential hazards, such as uneven flooring, protruding objects, or loose cords, and rectify these issues immediately.</li> <li>- Emergency preparedness: Establish a clear emergency plan and communication system for incidents involving slips, trips, and falls, as well as chemical spills or exposure. Make sure all team members are aware of the plan and know who to contact in case of an emergency.</li> </ul>	1L

			<ul style="list-style-type: none"> <li>- Train all staff members responsible for using the Rotowash on proper usage, inspection, and troubleshooting procedures.</li> <li>- Maintain detailed records of inspections, maintenance, repairs, and staff training related to the Rotowash machine.</li> <li>- Clearly communicate and display potential hazards and safety instructions through signage, labelling, and employee training sessions.</li> <li>- Encourage workers to report any unusual noise, smells, or signs of malfunction while operating the Rotowash so that early interventions can be made.</li> <li>- Refrain from modifying or using equipment that isn't designed specifically for use with the Rotowash so as not to increase the risk of accidents or equipment malfunction.</li> <li>- Consult with manufacturer and review manuals to gain a comprehensive understanding of the equipment's capabilities, limitations, and safety parameters to minimise potential risks.</li> <li>- Establish emergency response protocols and ensure all employees are familiar with these procedures, including but not limited to: stopping the machine, disconnecting the power supply, and notifying the workplace health and safety officer should an incident occur.</li> </ul>		
3. Transporting Floor Washer	Manual handling injuries; collision with other objects or people	2M	<ul style="list-style-type: none"> <li>- Ensure proper manual handling techniques are used when lifting and moving the Floor Washer, including bending at the knees and keeping the back straight.</li> <li>- Provide manual handling training to workers responsible for transporting the Floor Washer to ensure they understand safe lifting techniques.</li> <li>- Use a trolley or other appropriate mechanical aids if recommended by the manufacturer to transport the Floor Washer between areas, preventing unnecessary strain on the worker.</li> <li>- Assess the weight of the Floor Washer and ensure that no individual is lifting more than the recommended maximum weight without assistance.</li> <li>- Utilise at least two people to lift and transport the Floor Washer where necessary and appropriate based on its size and weight, sharing the load evenly.</li> <li>- Clear the path used for transporting the Floor Washer of obstructions or trip hazards before moving it, ensuring there's enough space for safe manoeuvring.</li> <li>- Communicate with team members and other individuals in the surrounding area about the movement of the Floor Washer, allowing them to be aware of and avoid potential collisions.</li> <li>- Maintain good visibility while transporting the Floor Washer to ensure any obstacles or hazards can be identified and avoided in advance.</li> <li>- Implement designated walkways or paths within the work area to minimise potential for collision with objects or other persons during transportation.</li> </ul>	1L

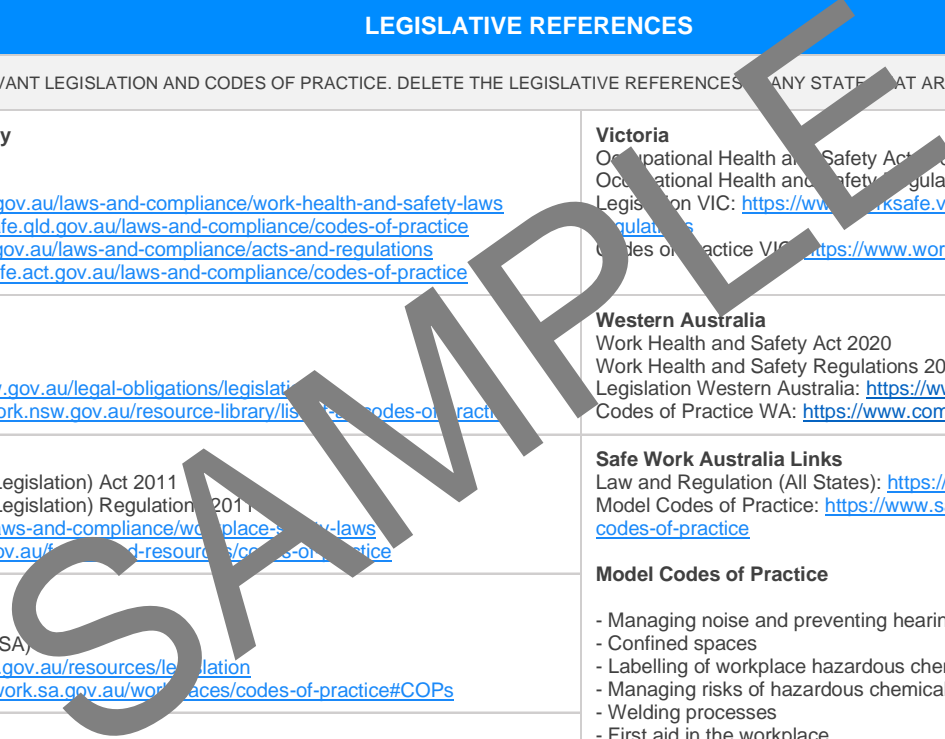

**SAFE WORK METHOD STATEMENT MONITORING AND REVIEW**

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
