If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Unstable conditions, Electrical hazards	3H	<ul style="list-style-type: none"> <li>- Conduct a thorough pre-start safety inspection of the area, checking for uneven or unstable ground conditions that could cause the gantry crane to tip or shift during operation.</li> <li>- Ensure proper maintenance and regular inspection of the gantry crane in accordance with manufacturer guidelines, and take corrective actions if necessary.</li> <li>- Provide appropriate safety training on the safe operation of the gantry crane, including a review of potential hazards, for all relevant workers.</li> <li>- Establish clearly defined work zones, using safety barriers or high-visibility cones, and ensure all non-essential personnel are excluded from the area during crane operation.</li> <li>- Implement a safety checklist to be completed before the commencement of each work shift, confirming all safety protocols in place and identifying any deviations or potential hazards.</li> <li>- Utilise lockout/tagout procedures to isolate any electrical sources or equipment connected to the gantry crane prior to operation and prevent possible risks of electrocution.</li> <li>- Display appropriate caution signs and warning labels, such as "Danger: High Voltage" or "Keep Clear: Crane Operation", to raise awareness of potential hazards around the work site.</li> <li>- Develop an emergency action plan that outlines steps to be taken in case of an accident involving the gantry crane, and ensure all workers are familiar with it.</li> <li>- Instruct staff to wear appropriate personal protective equipment (PPE) at all times, including hard hats, safety boots, high-visibility clothing, and gloves.</li> <li>- Regularly assess weather conditions in the work area, prioritise safe conditions for operations, and postpone the use of the gantry crane during extreme weather events, such as high winds, heavy rain, or lightning storms, which may pose increased risks of accidents.</li> <li>- Encourage open communication among all workers involved in the crane operation, empowering them to report potential hazards or concerns without fear of penalty, so as to facilitate a safer work environment.</li> </ul>	2M

			<ul style="list-style-type: none"> <li>- Implement a regular maintenance schedule for the gantry crane to minimise the risk of malfunction and check the service logs before each use.</li> <li>- Utilise accurate load calculations and ensure that the weight of the load is evenly distributed to avoid overloading or imbalance issues.</li> <li>- Employ the use of an independent third-party inspector, if required, to assess the structural integrity and functionality of the crane, along with verifying load calculations and limits.</li> <li>- Verify that all hydraulic systems and ropes/cables are in good condition without any visible signs of wear, tear, or damage that might adversely affect the lifting capacity of the crane.</li> <li>- Establish clear communication protocols for operators and ground personnel to relay information related to loads, their weight, and positioning requirements.</li> <li>- Incorporate redundant safety features such as limit switches and overload alarms that will help to prevent accidents resulting from improper loading, crane malfunctions, or other factors.</li> <li>- Ensure there is proper signage and barrier zones surrounding the crane operation area so non-essential personnel know not to enter the restricted work zone where potential hazards may arise.</li> <li>- Develop and implement detailed emergency response procedures to address situations where the crane experiences unexpected problems or malfunctions during operations, ensuring quick resolution to minimise risks to workers and property.</li> </ul>

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
