If an incident or a near miss occurs, all work must stead dately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.



Clearly mark paths with visible signs and tapet coulde workers safely around potential trip areas. Use ergonomic lifetime injugate such as bending a are knees, keeping the load close to the body, and avoiding twistime notions uring leng tasks. Conduct training session on manual beauting techniques to ensure all staff are aware of safe lifting practices. Ensure a vary on a kward loads are lifted by two or more people or use mechanical aids like trolleys and forklift. Provide personal productive equipment (PPE) such as gloves and steel-toed boots to improve grip and of projection. Secretal t limits for manual lifting to discourage attempting unsafe lifts by one person. Encourage employees to report any newly identified trip hazards immediately to supervisors. Initial proper lighting in all areas to improve visibility and early detection of hazards. Place warning signs near slopes, steps, or elevation changes to alert workers to caution points. Implement regular audits by a safety officer to assess compliance with trip hazard and lifting protocols. Schedule breaks for workers to minimise fatigue, reducing the risk of improper lifting techniques. 	1L

Implement a lockout/tagout system to ensure that machinery is safely shut down and cannot be accidentally started during maintenance or cleaning activities. Regularly inspect and maintain grain dryers to ensure they are functioning correctly and identify any potential defects or wear and tear that could lead to malfunction. Ensure that all protective guards and safety mechanisms on the dryer are in place and functional before operation begins. Provide appropriate personal protective equipment (PPE) such as heat-resistant gloves, aprons, and face shields for workers in close proximity to the dryer. SAFE WORK IN 'THE 'S' NTEMANT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remain effect, and must be reviewed (and revised if necessary) if relevant control measures are revised.
