If an incident or a near miss occurs, all work must stead adately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

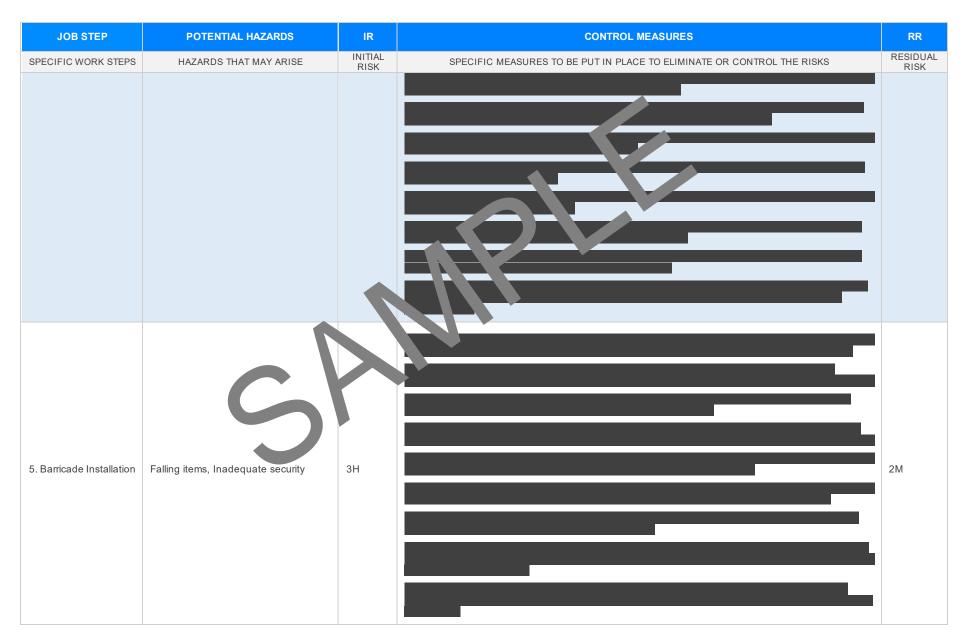

Site Inspection	Physical injury, Chemical risks	ЗН	 Ensure all workers are equipped with appropriate Personal Protective Equipment (PPE) such as hard hats, safety glasses, gloves, and high-visibility clothing to protect against physical injury. Conduct a comprehensive risk assessment prior to starting the site inspection to identify potential hazards related to both physical injury and chemical risks. Provide training sessions for workers on how to safely navigate the site, including recognising warning signs and avoiding hazardous areas. Erect clear signage and barricading around areas identified as having potential physical hazards to prevent unauthorised access. Implement strict access controls and only allow trained and authorised personnel to enter high-risk areas during the inspection. Use non-slip materials and secure tripping hazards such as cables or debris to minimise the risk of slips, trips, and falls. Establish a communication protocol to report any new hazards identified during the inspection immediately to the site supervisor. Ensure that emergency contact numbers and first aid equipment are readily available in case of an incident involving physical injury or chemical exposure. 	2M

SAFE WORK IN 'THIS 'S' ITEM ON MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remain effect, and must be reviewed (and revised if necessary) if relevant control measures are revised.
