ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

2. Site Assessment	Trips and falls, moving machinery	3H	<ul style="list-style-type: none"> - Conduct a pre-start meeting with all team members to discuss the site layout and potential hazards. - Clearly mark hazardous areas with cones or barriers to alert workers of trip and fall risks. - Ensure all pathways are clear from debris and equipment to minimise trip hazards. - Use high-visibility signage to indicate zones where moving machinery will be operating. - Implement a site-specific traffic management plan to control movement around the work site. - Equip workers with appropriate personal protective equipment, such as hard hats and high-visibility vests. - Regularly inspect the site for changes in conditions that may introduce new tripping hazards. - Designate a spotter to monitor moving machinery and alert operators of any potential dangers. - Create designated walkways separate from machinery operating zones to reduce the risk of collisions. - Provide training for all personnel on recognising and avoiding trip hazards and safely navigating areas with active machinery. 	2M
3. Marking Out	Eye injury due to dust or debris, cuts and abrasions	2M	<ul style="list-style-type: none"> - Provide and ensure the use of safety goggles to protect against eye injuries from dust or debris. - Use dust suppression methods, such as water sprays or dust extractors, during marking activities. - Ensure all tools and equipment used for marking out are well-maintained and free of burrs or sharp edges. 	1L

- Set up a designated area for marking out, away from other site activities to avoid potential collisions.

- Use visible barriers or cones around the marking area to alert others and define the perimeter.

- Require wearing long-sleeved clothing and gloves to protect skin from sharp edges.

- Implement a clean worksite policy to reduce loose debris that could become hazards.

- Conduct regular inspections of personal protective equipment (PPE) to ensure it is in good condition.

- Develop an emergency response plan, specifically for eye injuries and chemical exposures, with trained personnel.

- Limit personnel inside the marking out area to only those directly involved in the task to reduce exposure.

- Schedule regular breaks for workers to reduce fatigue, which can increase the risk of accidents.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
