ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Working at height, Use of heavy machinery	3H	<ul style="list-style-type: none"> - Conduct a comprehensive risk assessment prior to beginning work to identify specific hazards associated with working at height and using heavy machinery. - Ensure all personnel are trained in working at heights and the safe operation of heavy machinery, holding relevant certifications where necessary. - Install temporary edge protection, such as guardrails or toe boards, around areas where there is a risk of falls from height. - Use appropriate fall arrest systems, like harnesses and lanyards, for workers operating near edges or on elevated platforms. - Regularly inspect equipment used for working at height and heavy machinery for any damage or faults before commencing work. - Implement exclusion zones to keep unauthorised personnel away from the work area where heavy machinery is operating. - Ensure communication devices are available and functional, allowing clear communication between machine operators and ground personnel. - Arrange regular safety briefings to reinforce safety measures and awareness about site-specific risks before commencing daily work. - Ensure that weather conditions are monitored, halting operations if conditions become unsuitable or hazardous for working at height or machine operation. - Provide personal protective equipment (PPE) including hard hats, high visibility clothing, gloves, and hearing protection for all workers on-site. - Maintain clear signage around the site indicating hazards and restricted areas, particularly where heights and machinery operate. - Develop emergency response procedures tailored to potential incidents involving heights or machinery, ensuring all staff are familiar with these processes. - Utilise spotters or signal persons when machinery is in operation near other workers or potentially hazardous situations. - Schedule regular maintenance checks for heavy machinery to prevent malfunction or failure during operation. 	2M

Establishment of Base Layer	Entanglement in machinery, Crushing hazard from compactor	3H	<ul style="list-style-type: none"> - Conduct a comprehensive risk assessment before commencing work to identify specific hazards and appropriate controls for the establishment of the base layer. - Ensure all machinery operators are trained, competent, and hold current licences for operating relevant equipment. - Implement exclusion zones around operational areas to prevent unauthorised personnel from accessing high-risk zones. - Utilise spotters to assist in guiding machinery operations and ensuring clear communication between crew members. - Conduct regular equipment inspections and maintenance checks to ensure machinery is in good working condition and safety features are operational. - Equip all machinery with functioning audible alarms, lights, and reversing cameras to enhance operator awareness of their surroundings. - Mandate the use of personal protective equipment (PPE) such as hard hats, high visibility clothing, gloves, and steel-toed boots for all workers on site. - Develop and adhere to safe work procedures that outline step-by-step processes for safely establishing the base layer. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
