If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

**Note:** A SWMS must be reviewed regularly to make sure it remains effective. A SWMS must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

1. persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
2. persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
3. workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

Preparation	Manual handling, Exposure to hazardous substances	2M	<ul style="list-style-type: none"> <li>- Conduct a pre-start safety briefing to discuss the work scope, potential hazards, and safe work practices for workers handling Liquefied Petroleum Gas (LPG).</li> <li>- Provide appropriate manual handling training for all workers, including proper lifting techniques and ergonomic principles.</li> <li>- Assess and plan the task to minimise manual handling by using mechanical aids such as trolleys, hand trucks, and gas bottle lifting devices.</li> <li>- Wear suitable PPE, such as safety glasses, gloves, and closed-toe shoes, to protect from hazardous substances while handling LPG cylinders.</li> <li>- Ensure that all LPG cylinders are clearly labelled with correct identification and hazard information.</li> <li>- Inspect LPG cylinders before use to ensure they are free from damage, corrosion, or leaks.</li> <li>- Store LPG cylinders upright in a well-ventilated, designated storage area away from ignition sources and harmful substances.</li> <li>- Implement a documented cylinder inspection and maintenance programme to address damage, wear, and leakage.</li> <li>- Maintain clear access to emergency equipment such as fire extinguishers, eyewash stations, and spill containment kits.</li> <li>- Implement a procedure for reporting incidents, spills, or leaks involving LPG, ensuring workers are aware of their responsibilities.</li> <li>- Provide Material Safety Data Sheets (MSDS) for LPG and ensure workers understand the associated risks and control measures.</li> <li>- Conduct regular toolbox talks and refresher training on safe LPG handling, storage, and emergency response.</li> <li>- Clearly communicate and enforce a no-smoking policy in areas where LPG is being handled or stored.</li> <li>- Regularly review and update SWMS as needed based on work conditions, procedures, and the introduction of new technologies.</li> </ul>	1L

			<ul style="list-style-type: none"> <li>- Ensuring that employees receive training in safe LPG cylinder handling practices, as well as information on identifying potential hazards.</li> <li>- Utilising proper tools and equipment specifically designed for LPG cylinder handling and transportation, such as cylinder trolleys or cranes.</li> <li>- Applying leak detection solutions, spray, soapy water, during inspections to detect any leakage around cylinder connections and valves.</li> <li>- Monitoring and scheduling regular maintenance checks for LPG systems and related equipment, including hoses, regulators, and burners.</li> <li>- Implementing strict usage rules, such as not dropping cylinders or leaving them in unsecured positions where they might be knocked over or suffer a fall.</li> <li>- Ensuring that Pressure Relief Devices (PRDs) are present on LPG cylinders and are functioning adequately.</li> <li>- Establishing an emergency response plan, including evacuation procedures and first aid measures to be taken in the event of a detected leak or damaged cylinder.</li> <li>- Maintaining a log of cylinder inspections and results, including relevant dates, personnel involved, and any necessary follow-up actions required.</li> <li>- Routinely checking the valve caps for any signs of erosion, wear, or damage, and replacing them when necessary.</li> <li>- Providing additional protective gear for employees handling LPG cylinders, such as safety gloves, goggles, and appropriate footwear, to help prevent injury while managing cylinders effectively.</li> </ul>

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
