The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Surplained elementations of persons protective equipment (PPE) such as dust masks or respirators compare with Armologistation systems to capture and remove harmful dust at its source. Regult by interact and maintain tools and equipment, ensuring they are in good working condition to avent alfum and that may lead to dust exposure. Use one extraction tools when cutting or working with melamine products to minimise airborne particles. Imit the number of people working in confined preparations areas and organise tasks to reduce exposure time to dust. Conduct air quality monitoring to measure dust levels and reassess controls if necessary to ensure compliance with safe exposure limits. 	1L

Conduct pre-start checks on all machinery to identify any potential faults or maintenance issues. Install appropriate guards and barriers around cutting blades to prevent accidental contact. Ensure emergency stop buttons are functional and within easy reach of operators. Implement a regular maintenance schedule for all equipment to ensure optimal performance and safety. Provide operators with personal protective equipment (PPE) such as gloves, safety glasses, and steel-capped boots. Clearly mark designated work areas and enforce restricted access to authorised personnel only. Use lockout/tagout procedures to ensure equipment is not accidentally started during maintenance. Supervise operations to ensure compliance with safety procedures and intervene if unsafe practices are observed. Implement the use of personal protective enturnent (PPE), such as respirators or masks specifically rated for VOCs, to protect workers from intraction hazards. Provide heat-resistant gloves to safeguan workers om burns and high temperatures during the laminating process. Limit the duration of expose by rotating tasks mong words to reduce the amount of time any one individual is exposed to high mat or VOCs. Utilise low-VOCs come where possible to minimise the release of harmful compounds into the environment. Conduct regular mainterince check of unachinery to ensure that equipment used in the laminating process funds a ping of meetly and savery, thereby reducing potential risks. Train to loyees of safe handling and proper procedures when working with melamine and related substances of enhance hazard awareness and response. Install to exacquishs and heat detection systems near the work area to quickly manage potential fires to high heat exposure. Establish a protocol for immediate response and evacuation in case of emergencies related to heat xposure in VOC inhalation. whedule routine air quality monitoring to measure VOC levels in the workspace, ensuring they remain within safe limits as set by occupational health and safety guidelines. 	2M


