			<ul style="list-style-type: none"> <li>- Always carry out a full pre-use inspection of the machine, checking for any faults, defects or signs of wear and tear which could potentially cause harm.</li> <li>- Implement safety barrier systems or guards around dangerous moving parts to prevent clothing, hair, or body parts from becoming trapped or crushed.</li> <li>- Strictly enforce a policy of not wearing loose clothing, jewellery, or anything else that could potentially become entangled in the machine.</li> <li>- Regularly maintain and service the etching machine, according to the manufacturer's manual, to keep it in safe working condition.</li> <li>- Limit the number of workers involved in the set-up process, in order to reduce risk of accidents or miscommunication.</li> <li>- Cultivate a work culture that allows workers to stop work if they perceive any hazards or safety issues with the machine set-up.</li> <li>- Use mechanical aids to help with setting up heavy parts of the machine, reducing the risk of pushing injuries.</li> <li>- Encourage regular breaks so staff members are less likely to make errors due to fatigue, which could lead to accidents.</li> <li>- Keep the work area well-lit and clean to minimise the risk of slips, trips, or other mishaps associated with machine setup. Make sure emergency stop buttons are easily visible and accessible in case of any incident.</li> </ul>

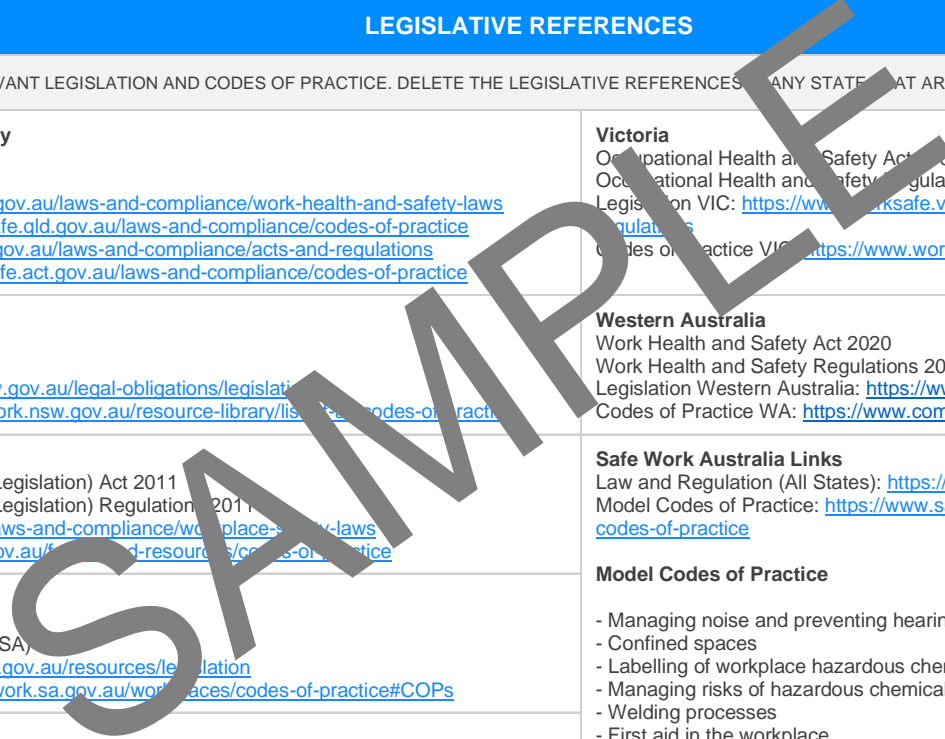

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
