Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.		
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.		
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.		
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

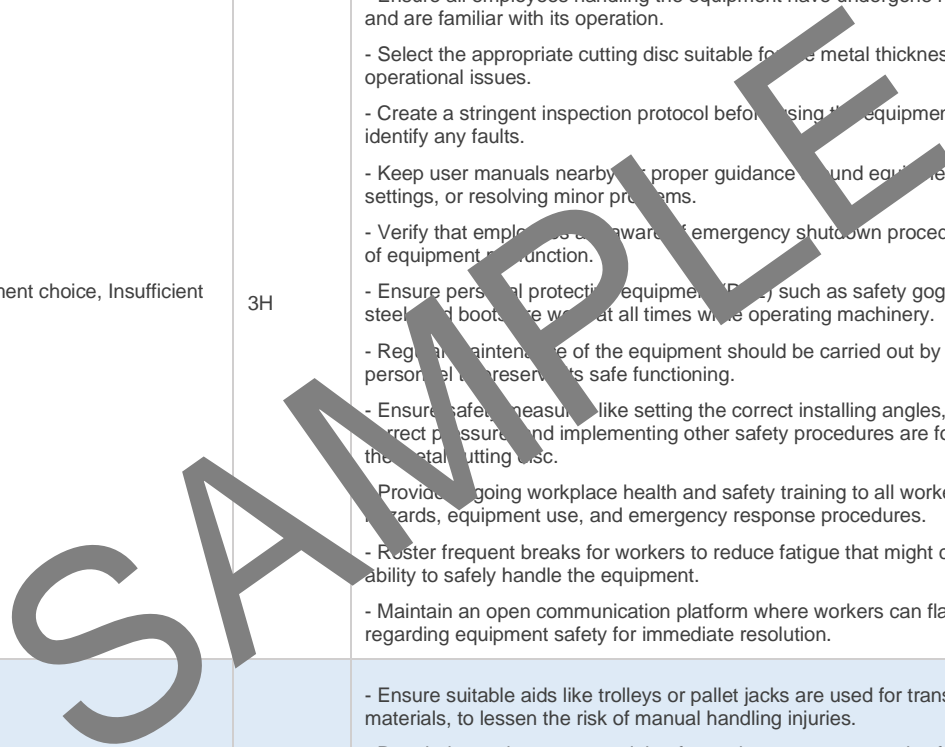

The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

1. persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
2. persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
3. workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

Preparation	Incorrect equipment choice, Insufficient training	3H	<ul style="list-style-type: none"> - Ensure all employees handling the equipment have undergone necessary training and are familiar with its operation. - Select the appropriate cutting disc suitable for the metal thickness to avoid any operational issues. - Create a stringent inspection protocol before using the equipment to preemptively identify any faults. - Keep user manuals nearby for proper guidance on equipment usage, adjusting settings, or resolving minor problems. - Verify that employees are aware of emergency shutdown procedures in the event of equipment malfunction. - Ensure personal protective equipment (PPE) such as safety goggles, gloves, and steel toe boots are worn at all times while operating machinery. - Regular maintenance of the equipment should be carried out by authorised personnel to preserve its safe functioning. - Ensure safety measures like setting the correct installing angles, maintaining the correct pressure and implementing other safety procedures are followed when using the metal cutting disc. - Provide ongoing workplace health and safety training to all workers about potential hazards, equipment use, and emergency response procedures. - Roster frequent breaks for workers to reduce fatigue that might compromise their ability to safely handle the equipment. - Maintain an open communication platform where workers can flag any concerns regarding equipment safety for immediate resolution. 	2M

Transporting Material	Manual handling injuries, Slips and trips	2M	<ul style="list-style-type: none"> - Ensure suitable aids like trolleys or pallet jacks are used for transporting heavy materials, to lessen the risk of manual handling injuries. - Regularly conduct proper training for workers on correct and safe lifting techniques. - Follow a 'team lift' approach when moving heavier items where a single worker's capabilities may be exceeded. - Clean up any spills, clutter, or obstructions that can cause slips, trips, or falls instantly. - Use personal protective equipment (like safety boots with non-slip soles) to safeguard against potential foot injuries and slips. - Maintain good housekeeping in the workplace. Ensure all paths and walkways are clear of debris, tools, cables, etc. - When loading and unloading materials, secure them properly to prevent any unwanted movement or dislodgement. 	1L

Replace any faulty equipment immediately. - Use safety guards on the cutting disc machinery at all times to protect workers from flying debris or malfunctioning parts. - Regular maintenance and inspection should be carried out by a qualified technician to prevent potential malfunctions. - Position equipment away from areas that conduct electricity or are damp to eliminate electrical hazards. - Employees handling the metal cutting disc should wear appropriate personal protective equipment (PPE), this includes but not limited to gloves, eye protection, and heat-resistant clothing. - Conduct regular training sessions for staff members to ensure they know how to safely operate the cutting disc machinery and what to do in event of a malfunction. - Implement a system for tagging and isolating faulty equipment so that it cannot be used until it has been repaired or replaced. - Have an emergency stop system in place that is easy to reach in case of any accidents or malfunctions. - Insist on proper shut-down and cool-down procedures after usage of each cutting disc to reduce risk of overheating or spontaneous malfunction. - Ensure that all power cords and plug points are undamaged, correctly rated, and fitted with current safety switches. - Keep the working area well-ventilated to manage heat build-up and fumes generated while working with the metal cutting disc. 	2M

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. 2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
