Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Keep workspaces free from clutter and ensure that all cables, tools, and materials are stored safely when not in use. - Install proper signage indicating potential hazard areas, helping people be more aware and cautious of their surroundings. - Provide adequate training for workers on how to properly use and handle shears and other cutting tools to avoid accidental slips or mishaps. - Ensure workers are wearing non-slip footwear suitable for the working environment. These should be regularly inspected for any wear and tear. - Schedule regular equipment check and maintenance tasks. This ensures that all machines and tools, including the metal cutting shears, are functioning optimally and safely. - Use barriers, guards or other safety devices to prevent accidental contact with sharp tools or potentially hazardous machinery. - Always disconnect tools from power sources prior to cleaning, servicing, or when not in use to mitigate electrical risks. - Where possible, replace conventional manual metal cutting shears with safer power tools designed for the specific task and follow strict lockout/tagout procedures during maintenance. - Enforce a strict work protocol that requires all workers to use personal protective equipment such as gloves, safety glasses, and coveralls. - Make sure that first-aid resources are readily accessible and that employees are trained in basic first-aid procedures. - Ensure proper lighting is present in the workspace. Poor lighting can lead to accidents caused by reduced visibility. - Regularly review and update your safe work method statement (SWMS) to reflect any changes in work processes or newly identified hazards. - Promote a safety culture within the company where workers feel comfortable reporting hazards, near misses, and incidents to help prevent future occurrences. - Schedule regular breaks for staff to prevent fatigue, which can increase the likelihood of accidents happening. 	1L

			<ul style="list-style-type: none"> - Regularly conduct safety inductions that appropriately address the procedures for equipment inspection and use. - Create a secure work environment, void of any water or moist surfaces to avoid accidents related to electricity. - Regular inspection and maintenance of power cords, plugs, switches and other electronic accessories. - Make sure that blades are kept clean and sharp to reduce the probability of accidents due to ineffective cutting. - Have an expert electrician inspect the gear annually to ensure it is electrically safe. - Always make sure hands are always a safe distance from the shear's moving parts to avoid hand injuries. - Do not operate the machine if any part is faulty, including safety guards. - Use the manufacturer recommended or standard compatible parts for repair or replacement. - Take breaks at regular intervals to prevent repetitive strain injuries and maintain focus. - Record all inspections, maintenance operations, and repairs carried out on the tool for future reference and compliance purposes. - Establish an emergency response plan that covers the actions to be taken in case of electrical shock, cuts, or other workplace accidents associated with the use of metal cutting shears.

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
