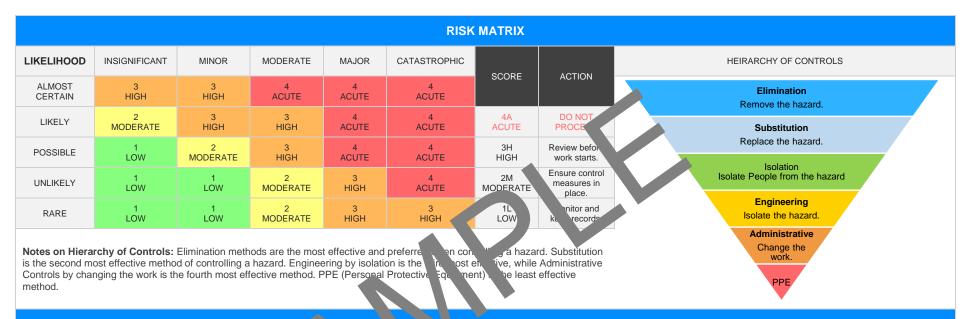

Notify all relevant parties about the time and date of equipment delivery, reducing the chances of unexpected vehicle movements and potential collisions. Mark a designated unloading zone, ensuring it has enough space and is safe from other worksite activities. Equip the delivery vehicle with fully functioning reverse alarms and flashing lights to alert workers and members of the public of its movements. 
