**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

**Note:** A SWMS must be reviewed regularly to make sure it remains effective. A SWMS must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

- persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
- persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
- workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

Filling Mortar Sprayer | Overfilling, Dust inhalation | 3H           | <ul style="list-style-type: none"> <li>- Always refer to the manufacturer's instructions while filling the mortar sprayer to avoid overfilling.</li> <li>- Use of automated filling systems can limit the risk of spills and overfills by controlling the amount of material being fed into the sprayer.</li> <li>- Operators should wear dust-resistant masks and other necessary protective equipment such as safety goggles and gloves for protection against dust inhalation.</li> <li>- Always fill the mortar sprayer in a well-ventilated area to ensure any possible dust is efficiently dispersed.</li> <li>- Use vacuum or wet suppression methods to control dust emissions during filling operations.</li> <li>- Implement training and awareness programmes for workers highlighting the adverse health effects due to dust inhalation and how to prevent it.</li> <li>- Regular maintenance and inspection of the mortar sprayer should be carried out to ensure its good working condition.</li> <li>- Safe work practices such as keeping an appropriate distance from the machine while filling can help prevent accidents.</li> <li>- Proper signage indicating hazards should be set up around the workstation to alert workers about the potential risks.</li> <li>- Avoid filling the sprayer to maximum capacity; instead allow some space which works as buffer in case of sudden pressure build-up within the sprayer.</li> <li>- Emergency response plans should be in place, including first-aid arrangements and immediate access to medical support if needed.</li> </ul> | 1L            |                    |

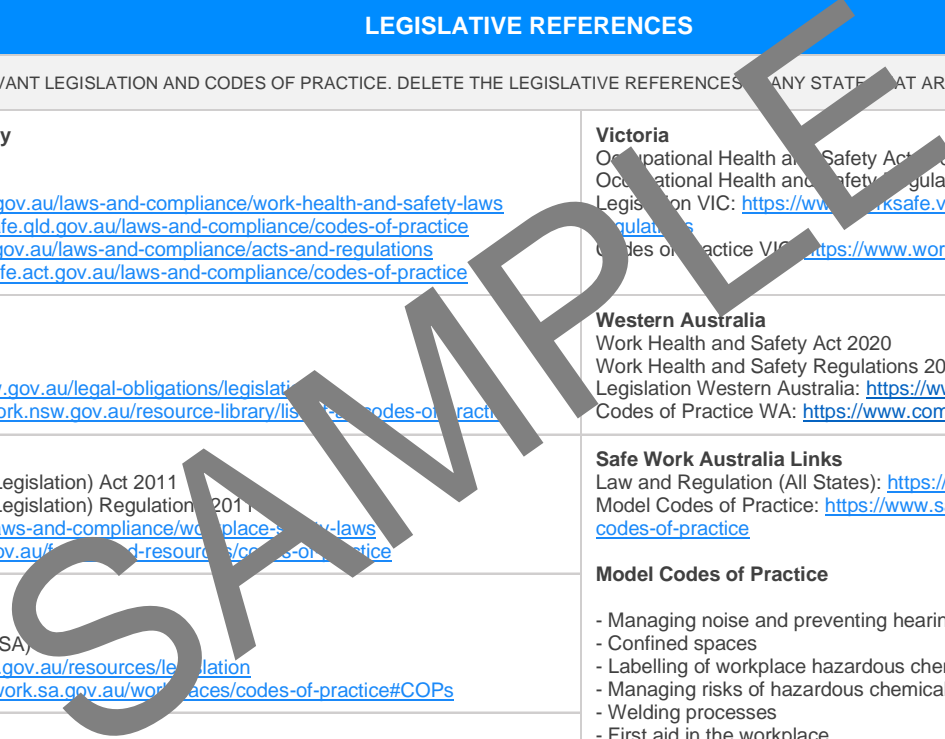

**SAFE WORK METHOD STATEMENT MONITORING AND REVIEW**

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
