If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

			<ul style="list-style-type: none"> <li>- Develop and implement a well-documented Standard Operating Procedure (SOP) for pre-operational inspection of order picker forklifts. This should include a clear sequence of steps to follow when conducting the inspection.</li> <li>- Implement a maintenance schedule and keep accurate records of all equipment servicing, repairs and any issues detected during pre-operational inspections. Ensure timely communication of these details to relevant team members for necessary action.</li> <li>- Provide operators with easy access to an updated checklist outlining the specific components and areas to be inspected during a pre-operational inspection, such as tires, brakes, forks, and hydraulic systems.</li> <li>- Encourage open communication among team members about any concerns or potential hazards identified through pre-operational inspections. Create a culture where it is understood that reporting potential hazards is essential for the well-being of everyone in the workplace.</li> <li>- Designate a competent supervisor or WHS representative to review pre-operational inspection results regularly and monitor team members' compliance with established SOPs and checklists.</li> <li>- Investigate any incidents, near misses or hazard reports related to improper pre-operational inspections and identify any trends or areas requiring improved controls or training.</li> <li>- Provide adequate tools and Personal Protective Equipment (PPE) (e.g., gloves, safety glasses, and high visibility vests) for operators and nearby workers during the pre-operational inspection process.</li> <li>- Make sure that the work area surrounding the order picker forklift is clear and free from obstructions, debris or other hazardous materials before commencing the pre-operational inspection.</li> <li>- Post warning signs and notices in visible locations reminding staff of their responsibility to conduct pre-operational inspections before using order picker forklifts.</li> <li>- Regularly review and update the pre-operational inspection process, checklists, and SOPs to ensure they remain current with industry standards, manufacturer recommendations and any changes in equipment or work procedures.</li> <li>- Establish a system to verify operator competency through regular observations of their performance during pre-operational inspections, as well as their ability to identify potential hazards and take appropriate corrective action.</li> <li>- Carry out risk assessments for each phase of the pre-operational process, identifying potential hazards and evaluating existing control measures' effectiveness to determine whether additional controls are required.</li> <li>- Proactively collaborate with industry partners, equipment manufacturers and regulators to stay informed of emerging best practices and new advances in technology that can help enhance the safety and efficiency of pre-operational inspections for order picker forklifts.</li> </ul>

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
