Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

- persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
- persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
- workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

Preparation	Tripping hazards, improper storage of materials	3H	<ul style="list-style-type: none"> <li>- Keep all work areas tidy, free from clutter and unnecessary materials to minimise tripping hazards.</li> <li>- Brief all workers about the importance of safe storage and handling of materials before starting the project.</li> <li>- Carry out regular checks and inspections throughout the day to ensure that safe practices are being maintained.</li> <li>- Store materials safely and methodically, ensuring weight is distributed evenly and stacked on flat, firm surfaces away from edges.</li> <li>- Use clearly marked or designated storage areas for different types of materials.</li> <li>- Install adequate lighting in working area to avoid low visibility which could lead to accidents.</li> <li>- Where possible, arrange delivery of materials to site so they coincide with when they are needed. This reduces the need for long-term storage.</li> <li>- Make use of safety cones or warning signs at the workplace to mark any potential tripping hazards.</li> <li>- Equipment and materials not in use should be stored securely out of the path of the workers.</li> <li>- Provide hands-on training to workers for lifting heavy objects and insist on the use of necessary personal protective equipment to prevent injuries.</li> <li>- All workers must wear appropriate PPE including solid footing shoes to prevent slips, trips and falls and hard helmets to avoid injury from falling material.</li> <li>- Formulate an Emergency Response Plan (ERP) so everyone knows what to do and where to go in case of emergencies. Regular drills need to be conducted to reinforce this plan.</li> </ul>	2M	
2. 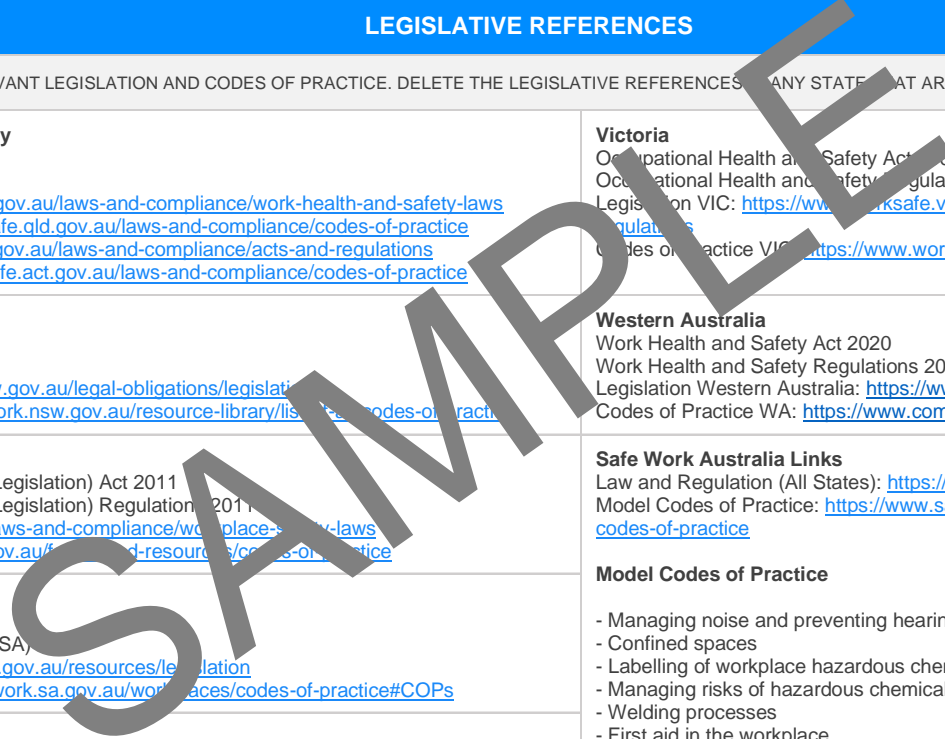

**SAFE WORK METHOD STATEMENT MONITORING AND REVIEW**

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
