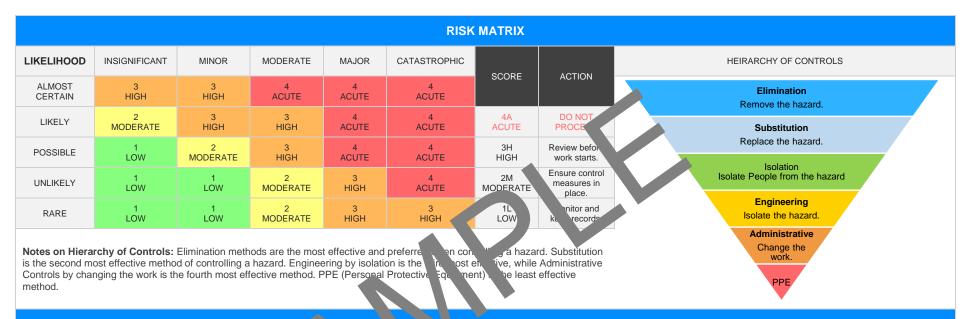

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Initial strict compliance with guidelines set out by the Workplace Health and Salety licensing authority for your region. Ensure all equipment is in good working order before starting the task. Regular inspections and maintenance will allow early detection of potential defects that may cause accidents. Lay out and secure hoses and cords in a manner that reduces the likelihood of tripping hazards. Use brightly coloured markers or safety flags to increase visibility. Designate a specific clear area for equipment setup where movement is limited and chances of tripping can be minimised.
