Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

			<ul style="list-style-type: none"> <li>- Carry out risk assessments prior to starting work each day, especially concentrating on weather conditions as rain could increase slip hazards and wind could increase risk of falling objects.</li> <li>- Ensure adequate lighting conditions to avoid unseen hazards related to falling objects or slippery surfaces.</li> <li>- Providing comprehensive safety training for all employees about identifying and managing risks associated with slipping and falling object hazards.</li> <li>- Develop an emergency response plan in case of injury from slips or falling objects, including nominated first aid officers.</li> <li>- Maintain a clear communication line among site workers to quickly relay any changes in conditions or potential hazards.</li> </ul> <p>Remember that Workplace Health and Safety is everyone's responsibility, and we can all help to reduce accidents by adhering to these measures!</p>

Remove Existing Insulation	Exposure to harmful substances, Accidental cuts	3H	<ul style="list-style-type: none"> <li>- Ensure that workers have received appropriate training on how to identify and handle harmful substances before commencing work.</li> <li>- Provide personal protective equipment like gloves, overalls, safety goggles and face masks to protect against accidental cuts and exposure to harmful substances.</li> <li>- Put in place lockout/tagout procedures to prevent accidental release of harmful substances if machinery or process is involved.</li> <li>- Regularly monitor air quality to ensure that the levels of hazardous substances are within acceptable limits.</li> <li>- Have a first aid kit readily accessible at the site.</li> <li>- Plan the work in such a way to minimise the duration and intensity of exposure to harmful substances.</li> <li>- Implement a proper waste disposal procedure to manage materials with harmful substances.</li> <li>- Use non-sparking tools and other explosion-proof equipment when working near flammable insulation materials.</li> <li>- Always maintain a tidy work area to minimise risks of trips and falls, as well as accidental exposure to harm substances.</li> <li>- Have a clear communication plan in place for emergencies that involves contact with harmful substances.</li> <li>- Conduct a thorough risk assessment before starting work to identify all potential hazards associated with the removal and re-installation of insulation and cladding.</li> <li>- Workers should take regular breaks to reduce exposure and fatigue, and thus lowering the risk of errors leading to accidents.</li> </ul>	2M



The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.

Think of this document as an internal audit review checklist before commencing work, and may form part of a Toolbox Talk (safety meeting) and may be used as an opportunity for education and training.
