Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

y hazards, Inadequate	2M	Sure, here are ten detailed control measures for safely managing fuel transfers: - Ensure all staff involved with fuel transfers have received appropriate health and safety training and precautions. - Develop comprehensive hazard identification policies and regular audits to ensure effectiveness. - Implement a strict policy outlining which employees have authority to make decisions; they must be properly inducted. - Make use of Personal Protective Equipment (PPE) mandatory, including safety glasses to safeguard against potential spills or splashes. - Engage in regular risk assessments and equipment inspections to identify and address any potential hazards promptly. - Appropriately train staff on emergency procedures in the event of a spill or leak. - Enforce strict compliance to the usage of safety data sheets available for all fuels. - Institute "No Smoking" rules within and around the areas where fuel transfer operations occur. - Display clear signage detailing necessary precautions and warnings to increase awareness of potential threats. - Regularly schedule drills and simulations to test reaction times and response processes. The results should be used to address any lapses and improve transfer operations.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and sub-contractors who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
