Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

1. persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
2. persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
3. workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

1. Preparation	Inadequate training, Lack of safety gear	3H	<ul style="list-style-type: none"> <li>- Ensure all workers using the side loader have undergone appropriate training on its operation. This includes correct procedures, potential hazards and emergency responses.</li> <li>- Regular toolbox talks will be conducted before work to reinforce safety measures and advice on any changes in procedures.</li> <li>- Adequate Personal Protective Equipment (PPE) such as high visibility clothing, steel-toed boots, safety glasses and gloves should be worn at all times during work.</li> <li>- All staff involved should familiarise themselves with relevant company safety guidelines and manuals before commencing work.</li> <li>- Safety instructions will be clear, visible and placed near the equipment for easy reference by operators.</li> <li>- Regular inspections of the side loader will be carried out to ensure the equipment remains in good working condition, preventing malfunction that may result in an accident.</li> <li>- Verify the reliability of the loading dock or working area. It must be flat, free of debris, and able to adequately support the weight of the loaded trailer.</li> <li>- Use buddy system while operating side loader trailers. The partner can assist in monitoring the surrounding environment and manoeuvring the vehicle safely.</li> <li>- Operators should stay vigilant about their surroundings, continually assessing for potential risks such as overhead lines, bystanders, or moving vehicles.</li> <li>- Limit speed when manoeuvring the side loader trailer to allow adequate reaction time in case of unexpected situations.</li> </ul>	2M	
2. 			<ul style="list-style-type: none"> <li>- Safety Manuals: Have access to up-to-date safety manuals for all heavy machinery and ensure all staff are familiar with the relevant safety guidelines.</li> <li>- Use of Personal Protective Equipment (PPE): Ensure that protective equipment is worn at all times when operating or performing tasks around the side loader trailer and make sure everyone has been properly trained on how to use it correctly.</li> <li>- Regular Breaks: Encourage regular breaks during long shifts to prevent fatigue which can contribute to oversight and accidents.</li> <li>- Incident Reporting: Create a culture where staff feel comfortable reporting faults or other potential problems with equipment without fear of repercussions.</li> <li>- Emergency Preparedness: Develop a comprehensive emergency response plan to deal with any incidents involving faulty equipment. Remedial action should be quick and appropriate for the situation.</li> </ul>

Loading Trailer	Falling objects, Slips and trips, Manual handling injuries	4A	<ul style="list-style-type: none"> <li>- Conduct a thorough risk assessment for each activity before beginning the process of loading the trailer to identify potential hazards and evaluate them.</li> <li>- Implement a safety communication system such as warning signs, marker cones or barrier tape to warn of the loading area, helping minimise risk from falling objects.</li> <li>- Floorwork should be prepared in advance designating the weight, size and placement of the load so it can be handled in a safe manner, reducing risks associated with manual handling injuries.</li> <li>- Supply personal protective equipment (PPE) including high-visibility clothing, hard hats, safety boots and gloves to all members involved in the loading process.</li> <li>- Ensure that employees are properly trained on working safely with the side loader trailer. Their knowledge about maximum load capacity, stability, and balance will help prevent accidents.</li> <li>- All personnel must be instructed to maintain safe distances when operating around machinery, loads, or other equipment used during the loading operation to avoid slips and trips.</li> <li>- Encourage regular breaks to reduce worker fatigue which often contributes to slips, trips and falls due to decreased alertness.</li> <li>- Install anti-slip mats or grip tape where relevant, particularly in areas that may become slick due to weather conditions or spillages.</li> <li>- Regular inspections of tools and machinery used during loading should be conducted to ensure their good condition, promoting safe and efficient workflow.</li> <li>- Offer proper training modules to the workers for best manual lifting techniques to protect against any strains or sprains while manually handling heavy loads.</li> <li>- Proper illumination is essential to ensure maximum visibility while loading the trailers, hence reducing the risks of slipping, tripping, or dropping loads.</li> </ul>	3H

**SAFE WORK METHOD STATEMENT MONITORING AND REVIEW**

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
