Stop work in case of extreme or unsafe weather conditions. - Encourage sensible and cautious walking on icy or snowy areas. - Make certain there is sufficient lighting where work is being conducted to increase visibility of potential hazards. - Ensure that shovels and mechanical equipment are maintained regularly to prevent unexpected malfunctions. - Avoid overexertion by keeping loads light when manually shovelling snow. - Create protocols for emergency medical treatment, should any injury occur, due to slips, trips or falls. - Enforce a strict no alcohol or drugs policy while on duty as this can impair balance, coordination and judgement leading to unnecessary risk. | 1L | |

| | | | <ul style="list-style-type: none"> - Providing training to recognize symptoms of cold-induced illnesses and injuries. - The area should be thoroughly assessed for uneven terrain that may pose trip and fall hazards. This can be done visually and with simple probing tools. - Employing the use of slope indicators or gradient apparatus to detect any dangerous slopes or unstable ground. - Use appropriate machinery, such as snow blower or ploughs, on uneven terrain where possible to minimise the risk of slips, trips and falls. - Mark out areas with conspicuously coloured stakes or flags where the becomes too steep or uneven for safe snow removal operations. - Installation of handrails or barriers where the ground is particularly treacherous could significantly enhance safety conditions. - Encourage all workers to report hazardous conditions that they come across immediately. These areas should then be cordoned off until the issues can be addressed appropriately. | | |

Using inappropriate equipment raises the risk of accidents and injuries. - If equipment appears unsafe, encourage employees to report immediately. - Use spare parts that fit securely. Ill-fitting components may cause potential dangers when operating snow removal machines. - Train employees to properly store and secure equipment after use to avoid sudden start-ups or unauthorized usage. | 2M | |

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
