Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Exposure to asbestos, Electrical hazards	3H	<ul style="list-style-type: none"> <li>- Conduct a thorough risk assessment to identify and document any potential exposure to asbestos before starting the demolition.</li> <li>- Engage a qualified professional to perform asbestos testing in all areas affected by the demolition work.</li> <li>- If asbestos is present, arrange for its safe removal by licensed asbestos removal contractors following Safe Work Australia's guidelines.</li> <li>- Implement strict access control, prohibiting unauthorised personnel from entering the work area where asbestos or electrical hazards are present.</li> <li>- Provide training to all workers on recognising asbestos materials and understanding the risks associated with electrical hazards.</li> <li>- Ensure that all electrical installations in the vicinity are identified, de-energised, and securely locked out before beginning any demolition activities.</li> <li>- Use warning signs and barriers to clearly demarcate areas where asbestos is found or suspected, and where electrical hazards exist.</li> <li>- Supply personal protective equipment (PPE) such as respirators, gloves, and protective clothing to all employees working near asbestos-containing materials.</li> <li>- Monitor air quality regularly in areas where asbestos is being removed or suspected to ensure fibres are not released into the environment.</li> <li>- Maintain all tools and equipment used in the demolition in good working order to prevent accidental contact with live electrical wires.</li> <li>- Establish emergency procedures and provide training on them to handle potential asbestos fibre release or electrical accidents.</li> <li>- Carry out regular safety briefings and review meetings to update the team on any changes or new risks identified during the project.</li> <li>- Document and report all incidents related to asbestos exposure or electrical hazards immediately to maintain compliance with Workplace Health and Safety regulations.</li> <li>- Review and update the risk assessment and SWMS documents regularly as the project progresses and conditions change.</li> </ul>	2M

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
