<p>If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.</p>		
<p>Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.</p>		
<p>The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.</p>

PPE (Personal Protective Equipment) is the least effective method.

2. persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
3. workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

Plant and Equipment setup	Faulty Equipment, Noise Pollution	3H	<ul style="list-style-type: none"> - Prior to the commencement of work, ensure all plant and equipment are in good operational condition - check for any visible damage or faults and conduct regular maintenance as necessary to avoid the risk of faulty equipment. - Provide personal protective equipment (PPE) to all workers on-site, such as hearing protection devices to reduce the impact of noise pollution. - Ensure that all employees are trained on how to correctly use the plant and equipment. This can prevent misuse that may lead to equipment faults. - Install quieter machinery and noise barriers where possible to reduce the level of noise at the workplace. - Schedule noisy tasks during times when they will cause least disruption and limit duration and intensity of noise to acceptable levels. - Encourage regular breaks for workers to limit their continuous exposure to high decibel levels. - Encourage proper communication between staff. Employees should report any issues with the equipment immediately so actions can be taken to resolve them. - Ensure plant and equipment are set up correctly according to manufacturer's instructions and specifications. Incorrect setup can lead to faults and raise noise levels. - Rotate workers operating noisy equipment - this reduces the exposure time for each worker. - Regularly check and maintain tools and equipment to keep them in optimal working condition, reducing hazardous vibrations and excess noise. - Have emergency procedures in place and ensure all staff members are aware of these procedures. They cover what to do in case of equipment failure or if noise levels exceed the acceptable thresholds. If a risk is identified, cease operations until it has been addressed. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
