Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, to conduct a risk assessment of those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

			<ul style="list-style-type: none"> - Barricade the work area: Erect temporary barriers or barricades around the installation site to prevent unauthorised access or accidental entry into the area by other workers, vehicles or members of the public. - Monitor weather conditions: Assess weather conditions before commencing work, particularly when working at heights. Delay or reschedule the task if conditions are deemed to be unsuitable, such as during high winds or heavy rain. - Utilise appropriate lifting equipment: When lifting and positioning frames, use suitable lifting equipment like cranes or hoists, operated by certified personnel, to help prevent potential collapses due to manual handling errors. - Conduct regular toolbox talks: Communicate with workers about potential hazards and necessary precautions on a regular basis through toolbox talks or pre-shift meetings. - Prepare an emergency response plan: Ensure there is a comprehensive emergency response plan in place, outlining clear procedures and assigning specific responsibilities to designated personnel. - Working at heights permit system: Implement a strict working at heights permit system where workers receive written authorization before starting work at elevated levels. This helps to ensure all safety measures have been considered and implemented prior to commencing work. - Establish a buddy system: Encourage workers to pair up with a 'buddy' when working on the frame installation, providing an extra set of eyes and ears to monitor each other's safety throughout the process.

The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
