Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

			<ul style="list-style-type: none"> <li>- Ensure that all machinery guards are securely in place to prevent access to moving parts and reduce the risk of entanglement. Regularly inspect these guards for damage or wear and replace them as needed.</li> <li>- Keep clothes, hair, jewellery, and other loose items secured to avoid getting caught in machinery during pre-operation checks, reducing the possibility of entanglement or injury.</li> <li>- Implement lockout/tagout procedures to ensure unauthorised personnel can operate the machinery during pre-operation checks and prevent accidental energising of the machine while maintenance or inspection is being performed.</li> <li>- Provide personal protective equipment (PPE) such as gloves, safety glasses, and high-visibility clothing for workers conducting pre-operation checks to protect against potential hazards.</li> <li>- Make sure that the work area around the Street Sweeper is clear of debris, obstacles, and slippery surfaces that could cause accidents or impede pre-operation checks.</li> <li>- Conduct regular training programs for workers on electrical safety principles, hazard identification, and proper machine operation, so they are equipped with the knowledge to carry out pre-operation checks safely.</li> <li>- Implement a system of regular machinery maintenance by qualified technicians to minimise the risk of unexpected breakdowns, electrical hazards, and entanglement during pre-operation checks.</li> <li>- Develop and maintain a Safe Work Method Statement (SWMS) for Street Sweeper operations, listing specific hazards related to the pre-operation checks and detailing the control measures to be followed by workers. ## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
