Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Incorrect manual handling, Exposure to hazardous substances, Fall from height	3H	<ul style="list-style-type: none"> <li>- Properly train workers on the correct techniques for manual handling to prevent injuries like strains, sprains or even fractures.</li> <li>- Ensure workers wear appropriate PPE, such as gloves and long-sleeved shirts, to protect against exposure to hazardous substances during preparation.</li> <li>- Set up a secure barrier around the work area to prevent any accidental falls from height during the preparatory stages.</li> <li>- Regularly inspect all equipment, including the Transit Mixer, before use to identify and fix any potential problems or safety hazards.</li> <li>- Implement a strict housekeeping policy to maintain a tidy and obstacle-free workplace, decreasing the risk of trips and falls.</li> <li>- Store hazardous substances properly, in line with Australian regulations, and avoid unnecessary handling to minimise exposure risks.</li> <li>- Consider adjusting decking platforms to reduce risks associated with working at heights during preparation.</li> <li>- Use mechanical lifting equipment, where possible, to aid in handling heavy or bulky loads, decreasing the risk of manual handling injuries.</li> <li>- Ensure workers are trained in the identification, handling and safe disposal of any hazardous substances they may encounter.</li> <li>- Provide regular breaks to ensure workers do not become overly fatigued, something that can lead to decreased concentration and increased accidents.</li> <li>- Involve workers in routine safety meetings and consult them about ways the safety in their work environment might be improved.</li> <li>- Support an open reporting environment where workers feel comfortable reporting potential hazards or risky behaviour without fear of retribution.</li> </ul>	2M	
2. 			<ul style="list-style-type: none"> <li>- Mandate use of signal lights when turning or changing lanes to inform other drivers of intentions.</li> <li>- Instruct drivers not to operate the transit mixer if there seem to be any mechanical problems and report immediately to supervisor.</li> <li>- Encourage defensive driving techniques to be aware, prepared, and able to respond to unforeseen incidents on the road.</li> <li>- Keep the transit mixer's lights, mirrors and windows clean for maximum visibility.</li> <li>- Advocate wearing seat belts all times while operating the vehicle.</li> <li>- Monitor vehicle's load capacity to ensure it is evenly distributed and never exceeded.</li> <li>- Make use of traffic management plans in areas with heavy vehicular movement to control flow and prevent accidents.</li> <li>- Enforce a zero-tolerance policy towards alcohol, drugs and fatigue related driving to eliminate such high risk behaviours.</li> </ul>

Mixer Loading	Dust Exposure, Noise Exposure, Hand injuries	4A	<ul style="list-style-type: none"> <li>- Ensure all staff involved are trained and adhere to safe loading procedures to prevent hand injuries. This includes proper techniques for lifting, pulling, pushing, or carrying, which should be detailed in a training program.</li> <li>- Provide personal protective equipment (PPE) such as dust masks or respirators to minimise the inhalation of dust during the mixer loading process.</li> <li>- Implement noise control measures such as earplugs or earmuffs for operators and nearby workers to reduce potential for noise-induced hearing loss.</li> <li>- Regularly maintain and check the condition of transit mixers to ensure they're in good working order to prevent malfunctions that could lead to accidents or increased dust/noise emission.</li> <li>- Implement regular breaks for mixer operators to minimise continuous exposure to hazards such as dust and noise. Workers should be given the opportunity to recuperate away from the worksite.</li> <li>- Use machinery with noise reducing features whenever possible. Transit mixers should be selected based on not just efficiency but also their noise emission ratings.</li> <li>- Clear signage indicating hazards, such as high dust areas or high noise areas, should be visibly placed around the work site. This will help raise awareness among staff and site visitors.</li> <li>- Regular health checks should be provided for the staff to detect any negative impacts due to dust and noise exposure at an early stage and treated accordingly.</li> <li>- Adequate ventilation should be provided where the mixer is loaded to disperse dust, reducing the concentration that workers might inhale.</li> </ul>	2M

All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
