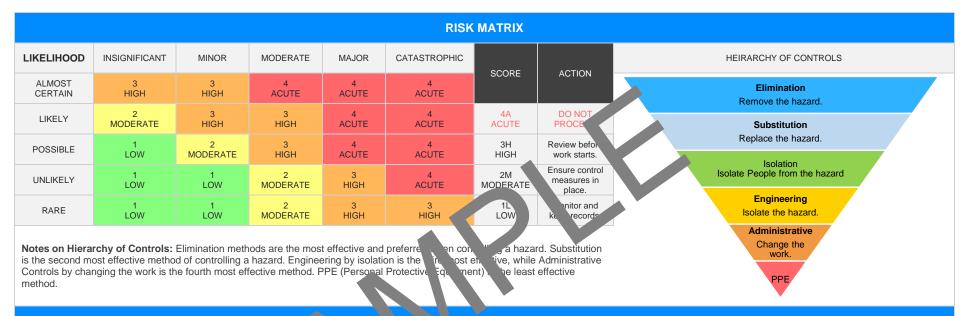

Encourage clear communication between team members throughout the preparation process to coordinate activities and prevent accidents resulting from misunderstandings or miscommunication. Implement and enforce a policy requiring workers to promptly report any hazards or unsafe conditions observed during the preparation stage, allowing for fast resolution and prevention of potential incidents. 	1L	
2. Material Handling	Manual handling injuries, Struck by objects	2M	 Proper training: Ensure all workers are trained in correct manual handling techniques and material storage before commencing work to prevent injuries. Use of appropriate Personal Protective Equipment (PPE): Workers should wear gloves, safety boots, and high-visibility clothing as required while handling materials to minimise the risk of injury. Implement a buddy system: Encourage workers to work in pairs when lifting or carrying heavy materials, so they can provide assistance and support to each other during movements. Clear communication: Communicate with workers ensure everyone is aware of their responsibilities and any notential hazards as ociated with exterial handling tasks.
