Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

This can be achieved by regularly tidying and removing unnecessary items from the workspace. - Wear appropriate personal protective equipment (PPE) at all times to minimise the risk of injuries. This could include safety footwear with slip soles, gloves for handling equipment and safety glasses. - Be sure that staff are properly briefed about the safe handling of equipment. They should be made aware of the correct lifting techniques to avoid injury. - Regularly inspect equipment for any damage or wear and tear that might make it unsafe for use. It should be replaced or repaired as required. - Use proper safety gear while working around water pump operations to prevent slipping or falling. - Select the right tools and devices for the particular task. Check them for any defects or damages before use. - Keep walkways clear of cords, hoses or any other obstructions that could lead to tripping accidents. - Make use of warning signs and barriers in high-risk areas, to alert others to potential hazards. - Confirm that the water pump is secured correctly before beginning operation. Loose machines may vibrate and cause falls. - Always carry out a thorough risk assessment before starting work. Understand all potential threats and have strategies in place to control them. - Ensure workers are appropriately trained on the significance of health and safety procedures as well as emergency protocols. Continuing education on safety measures will ensure their effectiveness. 	1L

Site Assessment	Unclear signage, Inadequate lighting	2M	<ul style="list-style-type: none"> - Conduct site inspections prior to starting any work, ensuring that all potential risks are identified and mitigating strategies are put in place. - Clear identification and proper placement of signage within the site is essential, helping to guide workers and prevent accidents. - Signage should be regularly checked to ensure they are accurate, present, and not faded or damaged, replacing if necessary. - The work area should be lit adequately using both natural and artificial light sources, to ensure visibility at all times during working hours, preventing accidents caused by poor lighting. - In case work extends into low-light times, sufficient auxiliary lighting should be installed beforehand, such as strong LED work-lights. 	1L

			<ul style="list-style-type: none"> - Reflective materials could also be used to improve general visibility around the work site, especially for key safety signage and areas of possible hazard. - Regular audits and risk assessments should be undertaken to identify hazards like unclear signage and inadequate lighting before they become major issues. - Mandatory safety procedures and protocols must always be adhered, including wearing appropriate personal protective equipment (PPE), like high-visibility clothing and hard hats. - Workers should be appropriately trained and educated about health and safety regulations pertaining to their roles within the workplace. - Finally, it's important to keep open lines of communication so that employees feel comfortable reporting any potential issues they notice around unclear signage or inadequate lighting on the site.

The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
