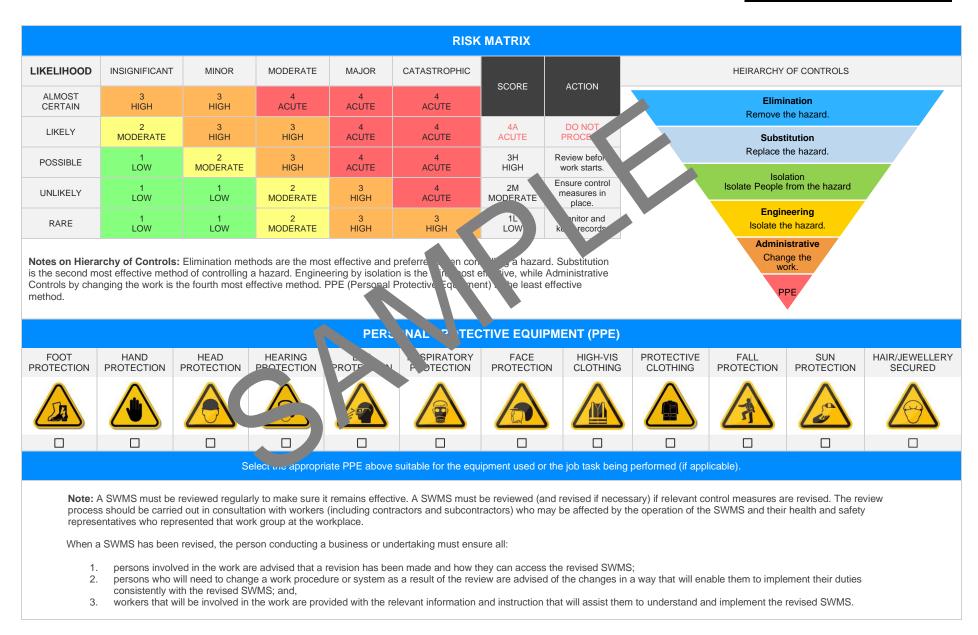

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Clearestructure, reacting safe work tractices should be communicated and displate at the Ventrace. Work of operation should be regularly assessed to ensure they are still fit to perform the twistafe. Supervents can monitor preparation procedures to control adherence to safety tellines, increase awareness of potential hazards, and maintain safe work continues. Facilitate regular toolbox talks to discuss safety measures and encourage input from workers about potential hazards or risky behaviour. Provide clear method statements outlining the correct procedures for tasks, which should clearly describe what needs to be done, how it is to be done, and the expected outcomes. 	2М

All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

- 1. Spot Checks.
- Consultation with workers, contractors and sub-contractors.
- 3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
